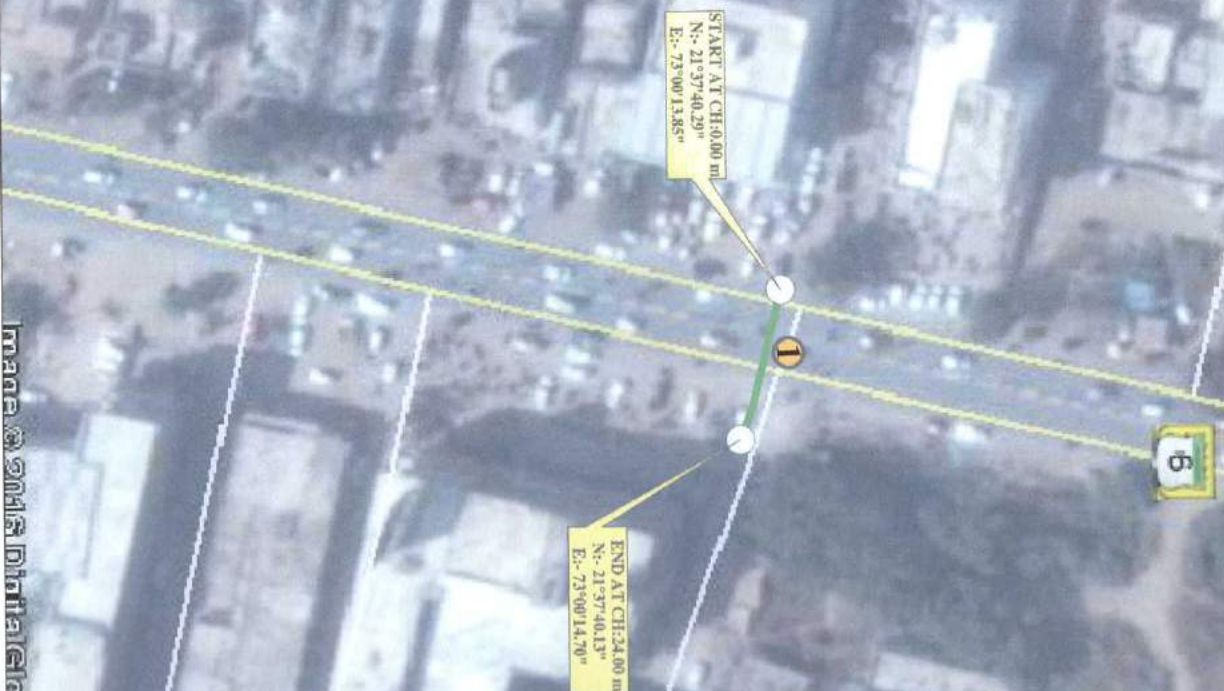


MAP SHOWING DGPS CO-ORDINATES OF FOREST AREA DEMANDED FOR DIVERSION

MAP SHOWING DGPS CO-ORDINATES OF FOREST AREA DEMANDED FOR DIVERSION

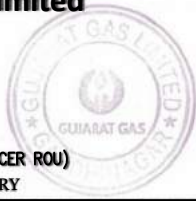

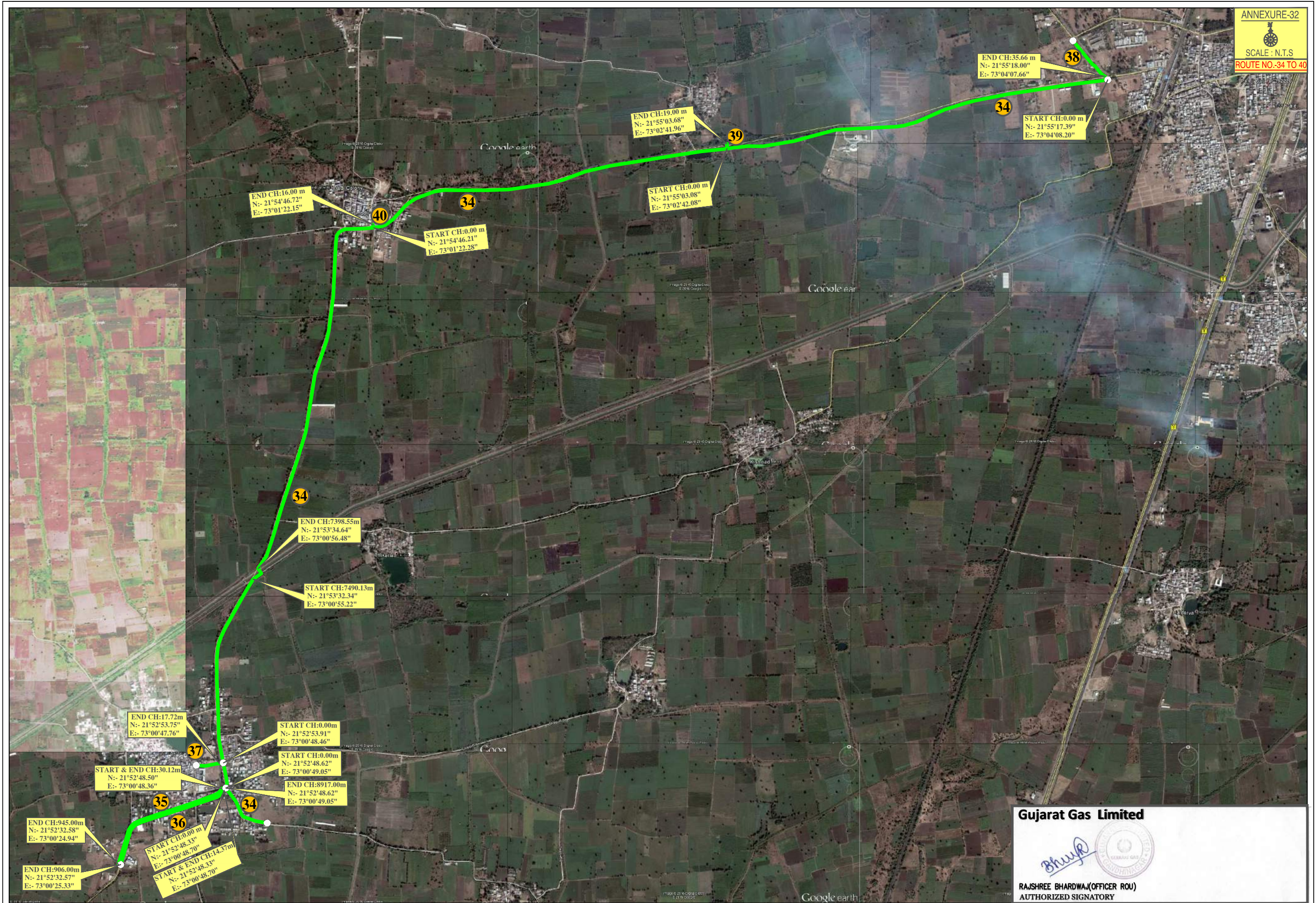

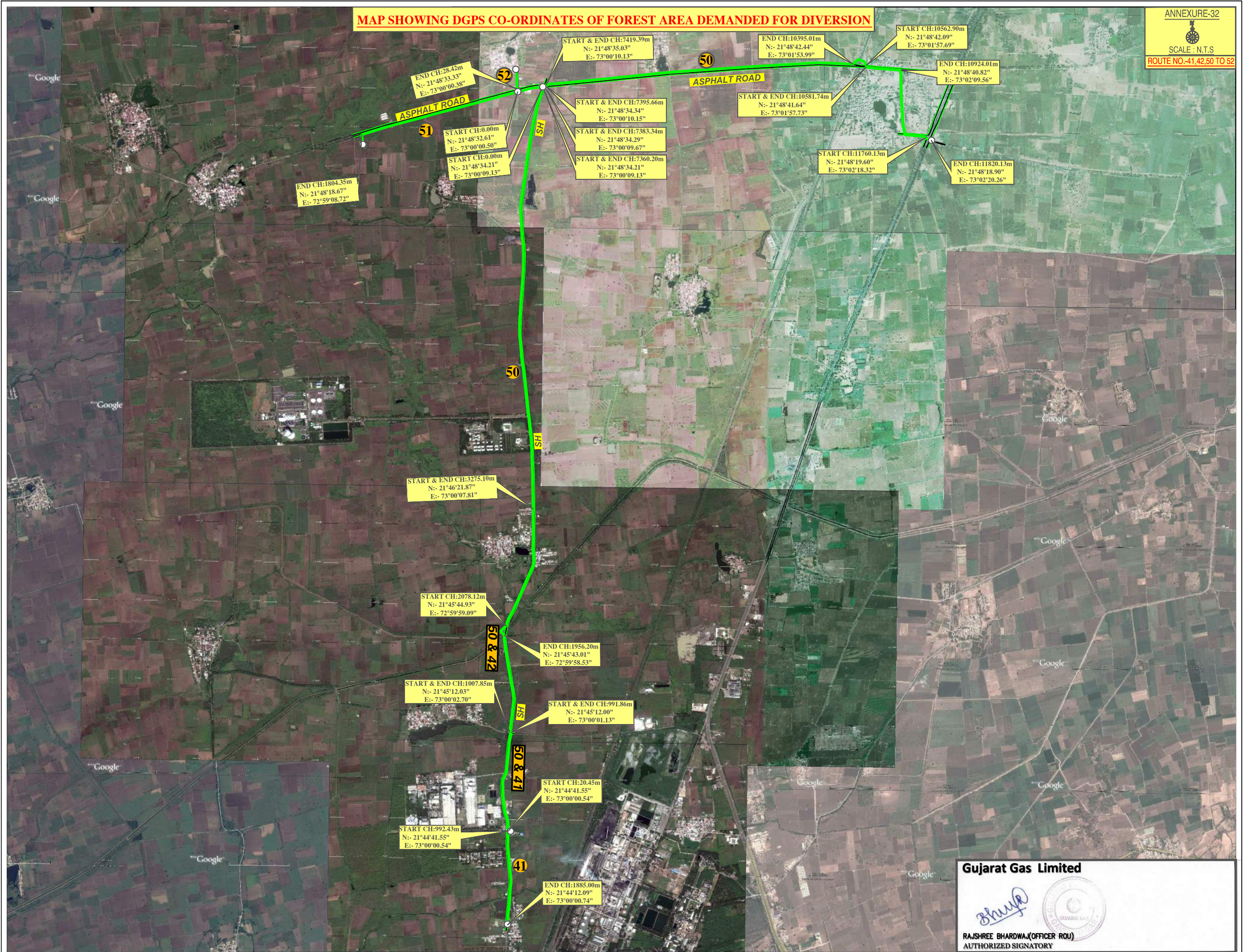
MAP SHOWING DGPS CO-ORDINATES OF FOREST AREA DEMANDED FOR DIVERSION

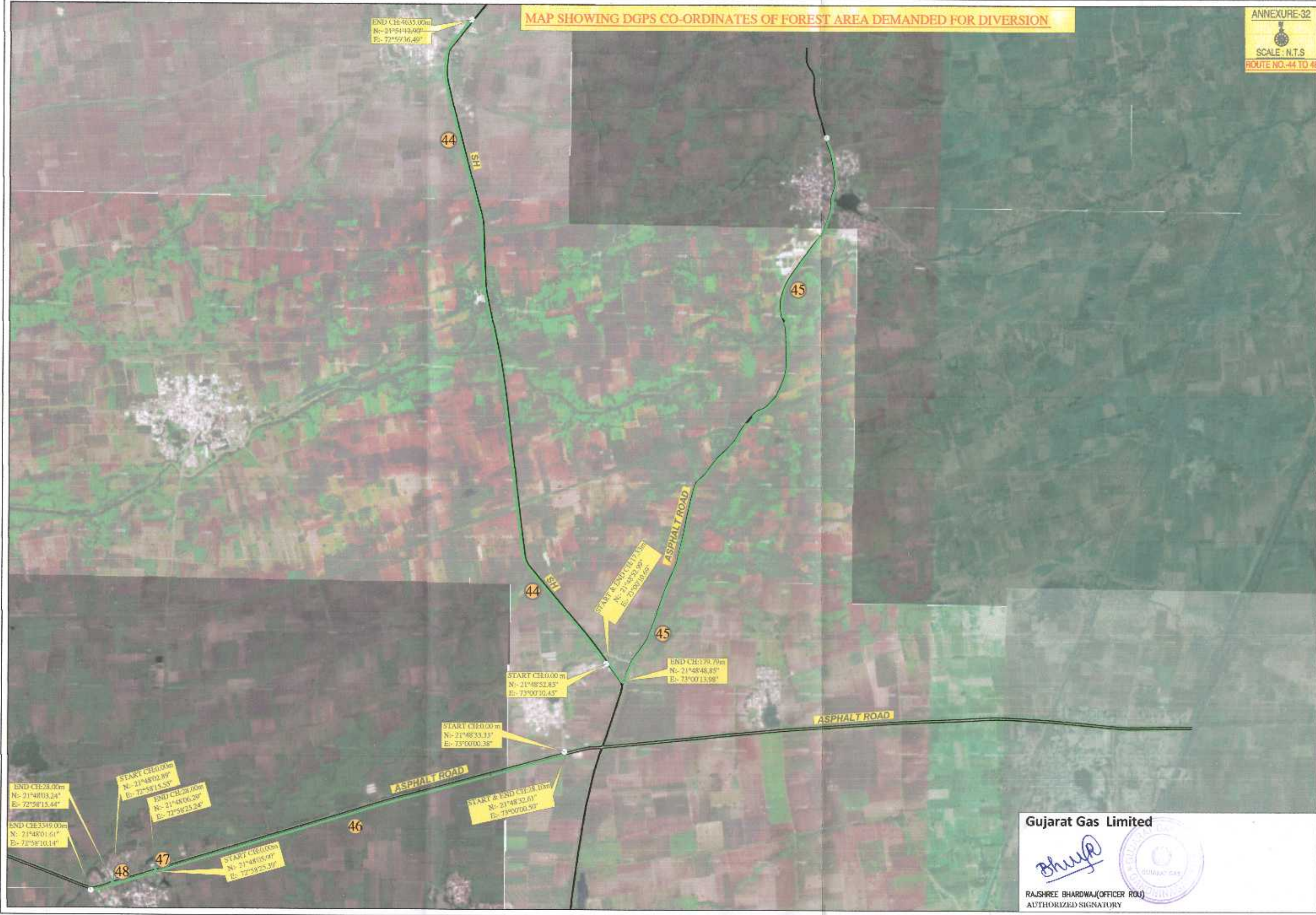

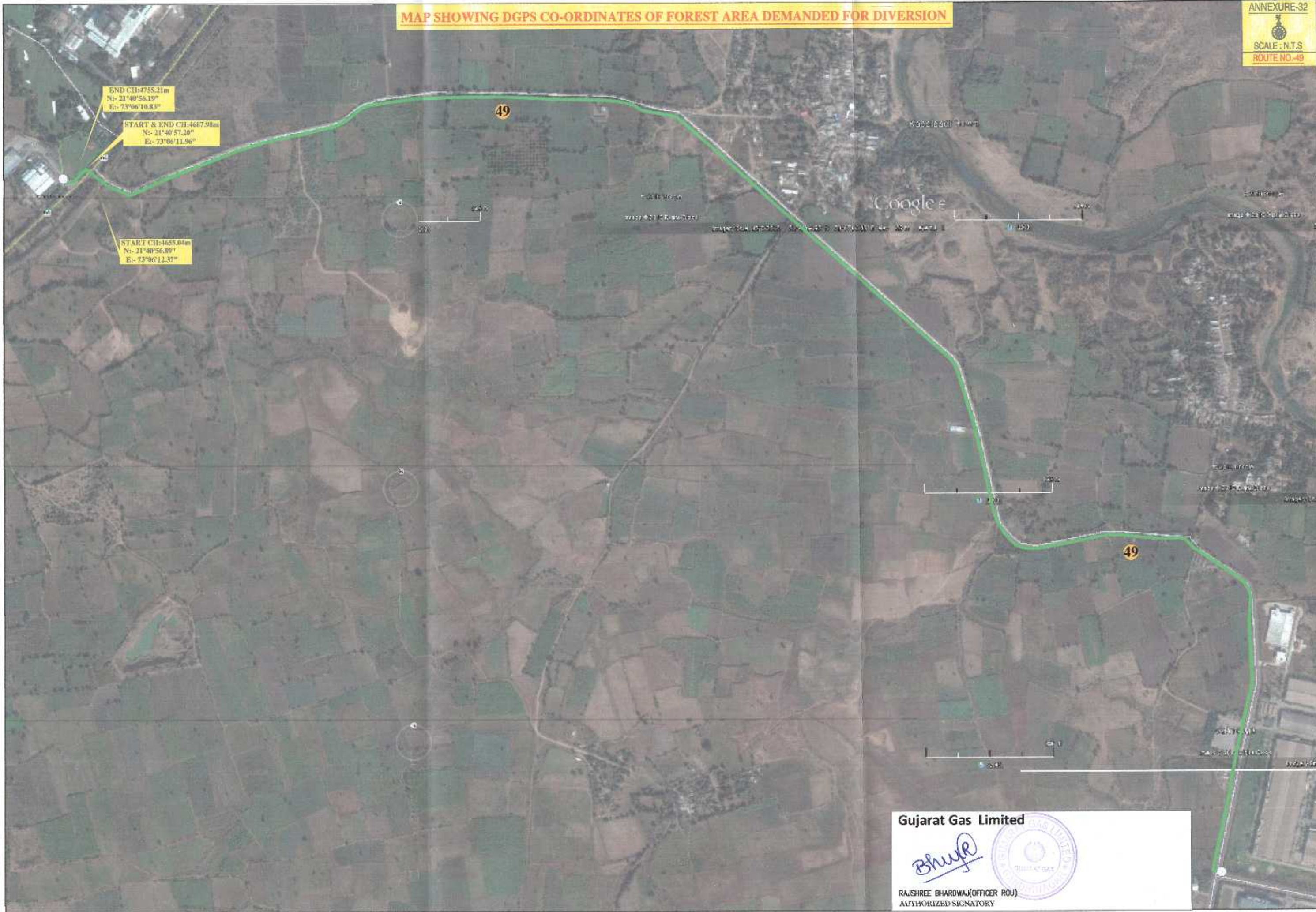


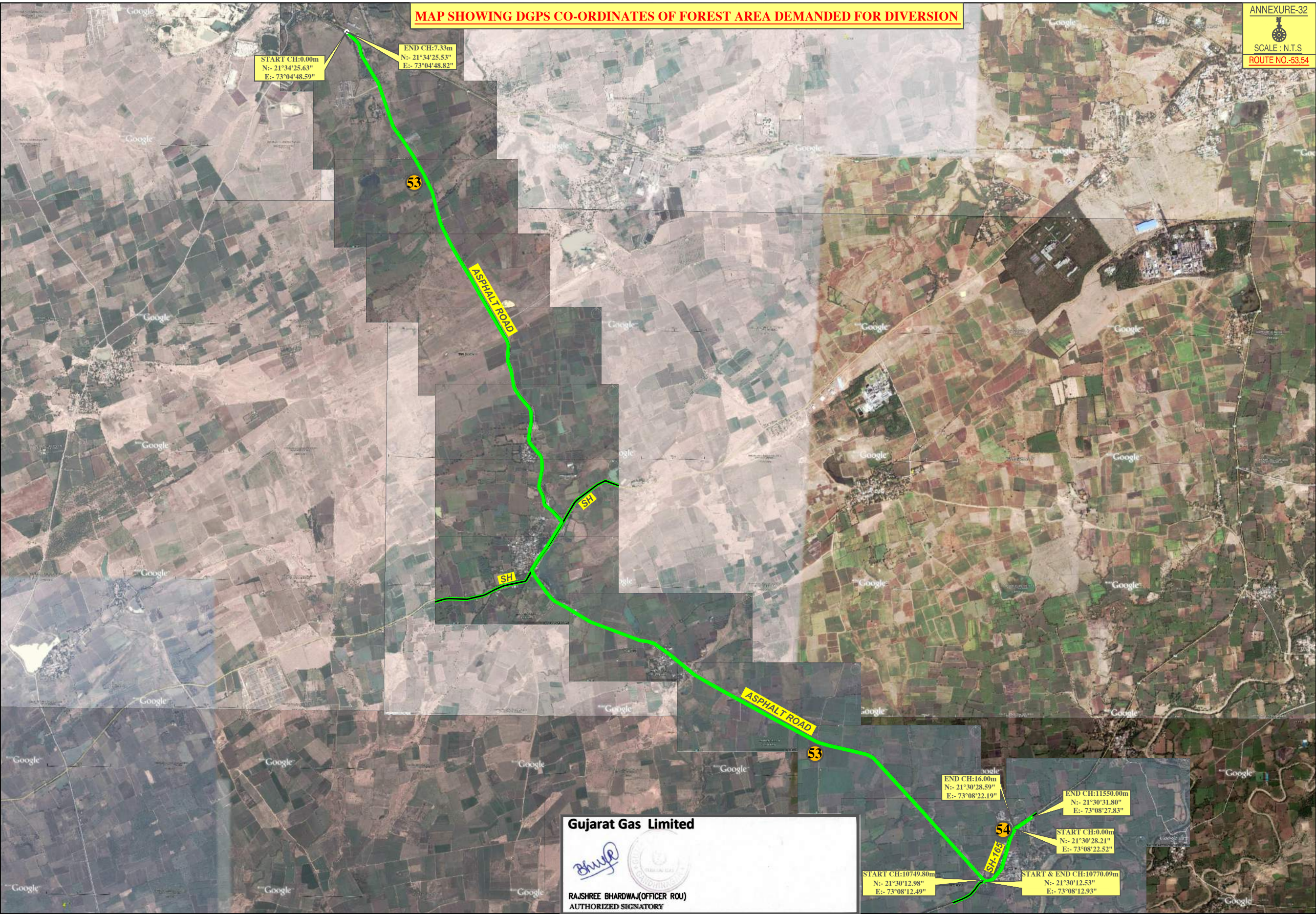
MAP SHOWING DGPS CO-ORDINATES OF FOREST AREA DEMANDED FOR DIVERSION

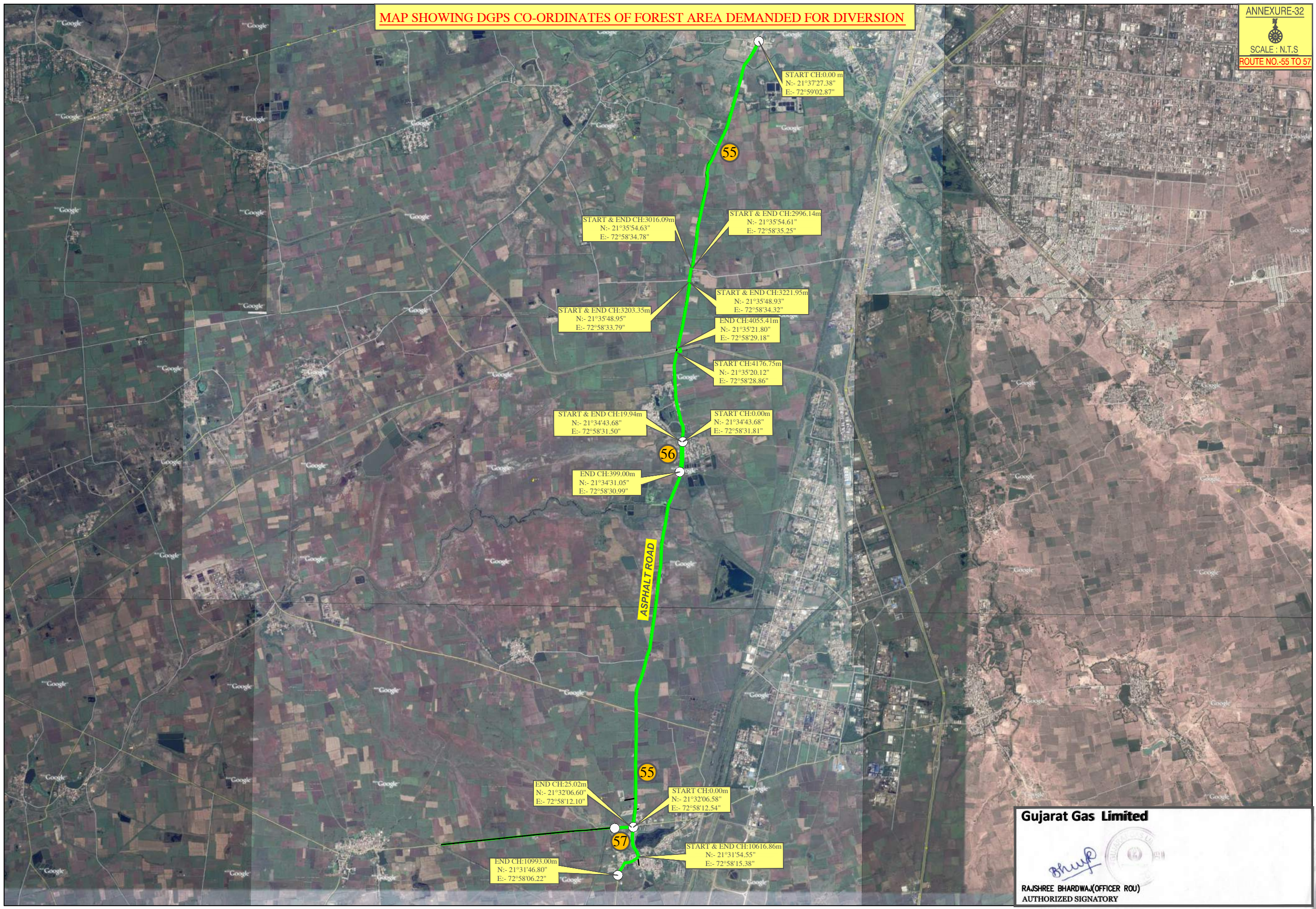
