TO WHOM IT MAY CONCERN

In compliance of the Ministry of Environment & Forests (MoEF), Government of India's letter No. 11-9/98-FC (pt) dated 03rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated & completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006 on the forest land proposed to be diverted for non-forest purposes. It is certified that Ac.10.849 of forest land purposed to be diverted in favour of Hotel Mayfair & Resorts (Ltd.), Bhubaneswar in Khordha District falls within the jurisdiction of Mauza-Jaydev Vihar, Unit-16, Bhubaneswar Tahasil.

It is further certified that:

- a) *The complete process for identification and settlement of rights under the FRA has been carried out for the entire Ac10.849 of forest area proposed for diversion. A copy of records of all consultations and meetings of the Grama Sabha/Sub-Division Level Committee and the District Level Committee are enclosed as annexure 1 to annexure 3.*
- b) *The Proposal for such diversion with full details of the project and its implications, in vernacular/local language have been placed before each concerned Gram Sabha of Forest Dwellers who are eligible under FRA.*
- c) *The each of the concerned Gram Sabha(s) has certified that all formalities/ processes under the FRA have been carried out and they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion.*
- d) *The discussion and the decision of the such proposals had taken place only when there was a quorum of minimum 50% of the members of Grama Sabha Present.*
- e) *The diversion of forest land for facilities managed by Govt. as required under Sec.3 (2) of the FRA have been completed and the Gram Sabhas have given their consent to it.*
- f) *The rights of the primitive tribal groups and pre-agricultural communities where applicable have been specifically safe guarded as per sec.3(1)(e) of the FRA.*
