Subject: Proposal for diversion of 48.288 ha of Forest Land for widening and improvement of main alignment of NH39 (Imphal-Moreh) of 29.526 km from Khongkhang to Moreh of Imphal-Moreh road section of NH-39 (New AH-02) under ADB funded.

Sir,

With reference to letter No. 3 MN C 030/2019-SHI 3936-37 dt. 05/03/2019 of the Conservator of Forests (Central), Government of India, Ministry of Environment, Forest & Climate Change, Shillong, I am to request you to deposit the following mandatory levies and all other dues to comply with the stipulated conditions in the letter stated above for diversion of 48.288 ha of Forest Land as follows:

1.	Cost of taking up Compensatory Afforestation over 97 ha	Rs. 199.16 lakhs to Ad-hoc CAMPA Fund (CAF in New SB account No. 520101263743620 of Corporation Bank, CGO Complex, Phase -I, Lodhi Road, New Delhi-110003)
2.	Net Present Value (NPV)	Rs. 13.5292490 crore to Ad-hoc CAMPA Fund Account as above.
3.	Cost of Felling/Logging/Transportation/ Demarcation & Erection of Boundary Pillars, maintenance etc.	As assessed by the concerned DFOs to be deposited directly to his account

Further, the amount as indicated above should be deposited through e-payment to the Ad-hoc CAMPA Fund account against this demand after generating a physical or NEFT-RTGS Chalan online by logging into <http://forestsclearance.nic.in> or <http://efclearance.nic.in>. It is also to inform you that no work should be taken up until the mandatory levies are deposited and work permit is granted by the state government.
