In Compliance of the Ministry of Environment and Forests (MOEF), Government of India's Letter no 11-9/98-FC (Pt.) dated 3rd August 2009 wherein the MOEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other traditional forest dwellers (Recognition of forest Rights) Act, 2006 (FRA for short) on the forest land proposed to be diverted for non forest purposes read with MoEF's letter dated 5th February 2013, wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 5.903 Ha (3.935 length) of forest land proposed to be diverted in favour of Divisional Manager, Madhya Pradesh Road Development Corporation, Distt. Dhar for Alirajpur-Mathawad Road in Alirajpur District falls within jurisdiction of Bakhatgarh, Kherwada, Karajwani, Mathawad villages in Sondwa Tehsil.

It is further certified that :-

1. the Complete process for identification and settlement of rights under the FRA has been carried out for the entire 5.903 Ha (3.935 length) of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee(s), Gram Sabha(s), Sub-Division Leval Committee(s) and the District Leval Committee are enclosed as annexure II,
2. the Diversion of forest land for facilities managed by the government as required under section 3 (2) of the FRA have been completed and the gram Sabhas have given their consent to it,
3. the proposal does not involve recognised rights of Primitive Tribal groups and pre-agricultural communities.



Government of India's Letter No. 11-9/98-FC (pt) dated 3rd August 2009 Wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of right under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes, it is Certified that **5.903 Ha (3.935 length)** of forest land proposed to be diverted in favour of Madhya Pradesh Road Development Corporation, Dhar for project of Alirajpur-Mathawad Road (purpose for diversion of forest land) in Alirajpur falls within jurisdiction of **Bakhatgarh, Kherwada, Karajwani, Mathawad village(s)** in Alirajpur district.

It is further certified that ;

- a) the complete process for identification and settlement of right under the FRA has been carried out for the entire **5.903 Ha (3.935 length)** of forest land proposed for diversion A copy of record of all consultation and meeting of the Forest Rights Committee(s), Gram Sabha(s), Sub Division Level Committee(s) and the District Level Committee are enclosed as annexure II;
- b) the proposal for such diversion (with full Details of the project and its implication, in vernacular/local language) have been placed before each concerned Gram sabha of Forest dwellers, who are eligible under the FRA,
- c) the each of concerned of Gram Sabha(s) has certified that al formalities/ processes under the FRA have been carried out and that they have given there consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the Gram Sabha **Bakhatgarh, Kherwada, Karajwani, Mathawad village(s)** is enclosed as annexure II;
- d) the discussion and decisions on such proposals had taken pace only when then was a quorum of minimum 50% of the member of Gram Sabha present;
- e) the diversion of Forest land for facilities managed by the Government as required under section 3 (2) of the FRA completed and the Gram Sabha have given their consent to it;
- f) the right of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3 (1) (e) of the FRA.
