I submit the following few lines for favorable consideration of my request for allotment of 0.20 acres of Forest Land in Hyderabad Division.

Mudmiyal Kancha, Farmers & Farm —Houses Association is having about hundreds of acres of agriculture land in Mudimiyal Village, which is adjoin to the Reserve Forest. We are using the existing cart track to reach out land to carryout day to day agriculture work. The existing track is in use from our ancestral days.

All of a sudden, recently the local Forest Department have obstructed us for using the said road, claiming that the said portion of land is forest land.

As there is no option for us to reach out agriculture land and in order to avoid any further legal complications, we are proposing for diversion of the existing road in our favour to a length of 193 meters and with a width of 10 meters.

Total forest area involved will be 0.20 acres.

In this connection, I have carried out the DGPS survey of the area in question duly hiring a private agency and the same has been authenticated by your kind self vide ref cited.

Accordingly, as directed in the ref cited I am submitted herewith the proposals in prescribed formats in (7) sets I have also applied the proposal through online.

I request the kind principal Chief Conservator of Forests, AP, Hyderabad to do the needful in obtaining necessary clearance from the competent authority for allotment of 0.20 acres of Forest land and I am ready to pay the compensation towards forest area applied as per the Government Norms.
