

In this connection, it is submitted that the PUC's under subject received in this office from the O/o District Forest Officer has been examined carefully and the clarification is submitted as under:-


The administrative approval of the project is from RD 0 to 2800 and 3000 to 9990 mtr. for which photocopy attached for ready reference . The forest clearance actually required from RD 0 to 2800 and 3000 to 3650 mtr. of the road falling under the jurisdiction of forest division Kurukshetra. The RD 0 to 3.65 was written in file no. HRB022/2019-CHA as per area falls under the jurisdiction of forest division Kurukshetra.

It is further submitted that from RD 2800 to 3000, the road passes through thickly populated area of village Kheri Ram Nagar and no forest trees are exists in the reach of RD 2800 to 3000 as there is no ROW of PWD are exists along the cement concrete pavement road on both side as only side drain are exists between the edge of the road and houses. Residential house are exists of village Kheri Ram Nagar on both sides of the road as shown on the linear plan. Hence the forest clearance may kindly be considered from RD 0 to 2800 and 3000 to 3650 under the jurisdiction of forest division Kurukshetra.

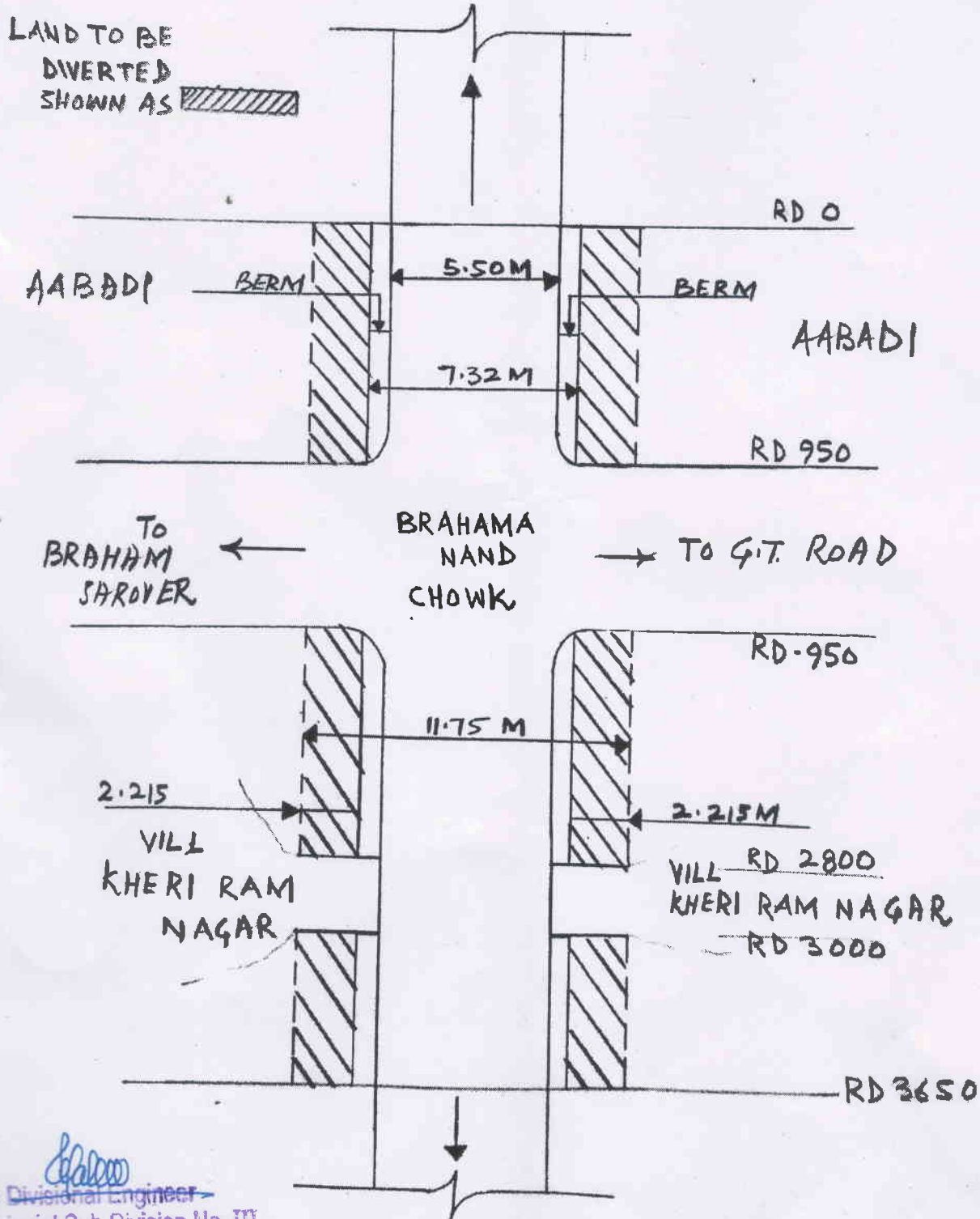
