### Abstract

Higher Education Department – Acquisition of land for setting up of new Indian Institute of Technology (IIT) in Palakkad, Kerala – Sanctioned - Orders issued.

### ORDER

The Finance Minister, during the Budget Speech for 2014-2015, made an announcement to set up an Indian Institute of Technology (IIT) in the State of Kerala and Government of India have appointed a Site Selection Committee for selecting a suitable land for the purpose. As recommended by the Site Selection Committee, the Government of India has decided to set up an Indian Institute of Technology (IIT) in the State of Kerala at the site measuring 500.19 acres of land situated at Pudussery West Village in Palakkad District (Survey Numbers as per Annexure)

As per Government Order read as 2<sup>nd</sup> paper above, Shri.M.Sherif, Additional Secretary to Government, Higher Education Department, Government of Kerala, was nominated as the Requisitioning Authority for acquisition of land.

The details of land proposed for the project are as follows:

1. Private land to be acquired	-	366.39 acres	367.87
2. Panchayath puramboke	-	20.78 acres	21.84

From the above, an extent of 70.02 acres of land which was resumed from the Industries Department is already available with the District Collector, Palakkad. An extent of 20.78 acres is with Pudussery Grama Panchayath and the same can be asked to be transferred to District Collector, Palakkad. An extent of 43.00 acres of vested forest land that needs to be de-vested following the procedures of Forest Department.

As per Government Order read as 3<sup>rd</sup> paper above, sanction was accorded for the acquisition of private land for the setting up of IIT in Pudussery West Village in Palakkad District and the District Collector , Palakkad, was authorised to resort to negotiated purchase of private land.

Government have examined the matter in detail and the following orders are issued:

1. The acquisition of private land of 366.39 acres (Dry land – 112.44 acres, Wet land – 253.95 acres included in the Annexure) of Block No.30 of Pudussery West Village of

Palakkad Taluk will be done under Fast Track Programme, by invoking urgency clause under 17(4) of Land Acquisition Act.

2. The District Collector, Palakkad must submit proposal for classification change of 253.95 acres of wet land to the Agriculture Department as per the provisions contained in the Wet Land Act 2008.

3. An extent of 43.00 acres of vested forest land will be handed over to the IIT authorities subject to de-notification of the same from the provisions of The Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2003. The Forest Department will take urgent necessary action for de-vesting the land of 43.00 acres from its present status of vested forest land.

4. The Pudussery Grama Panchayath will transfer an extent of 20.78 acres of land to the District Collector, Palakkad, as per prescribed procedure and the Collector in turn will hand over the same to the IIT authorities.

5. The District Collector, Palakkad, as per direction read as 4<sup>th</sup> paper above, will consider the requisition in Form - 2 and will submit the proposal for issuing Notification under Section 4(1) of the Land Acquisition Act and orders under Section 17(4) of Land Acquisition Act to Government.


