As the User Agency is MoRT&H (Central Government or a Central PSU, the dispensation of compensatory afforestation over double the degraded forest land, instead of equivalent non-forest land will be available in such cases.

In compliance to the aforementioned decision, proposal for diversion of forest land for upgradation of declared National Highway (owned by MoRT&H) are to be reuploaded on the web site of PARIVESH with User Agency MoRT&H.
