Certificate of Undertaking

National Highway & Infrastructure Development Corporation Limited (NHIDCL), hereby give the undertaking to bear the cost of raising and maintenance of Compensatory Afforestation and Net Present Value as well as the cost of protection and regeneration of scheme prepared by Department of forest, Environment and Wildlife Management, Government of Sikkim in respect of diversion of 2.6808 Ha and also undertake that :

1. For Public welfare schemes of the non commercial Government Ventures like school, Rain water harvesting, Tanks, Sewer lines, Village Roads, which are meant for Public Welfare, the NPV may not be charged and that in case it is finally decided by the supreme Court such Projects are not exempt from payment of NPV the user agency, PMU Gyalshing, NHIDCL will pay the amount of NPV as determined and order of supreme court.
2. NHIDCL, hereby give an additional undertaking that incase of any upward revision of rate of NPV (as per the report of Expert Committee Constituted by the Supreme Court and the final decision in this respect by the Supreme Court) the Department shall pay the amount of differential NPV.
