## Memorandum:-

This office has given an " In Principle" approval for diversion of 1.179 Ha. of Protected Forest land for Underground laying of Optical Fiber cables lines along the Routes vide this office letter date. 26/11/2018 referred above at (5)

The Railtel Corporation of india Ltd , Bhavnagar Exempt from cost of processing fee and Registration fees, as per forest& Environment Department, Government of Gujarat letter no. FCA/1016-290-F Dt. 25/05/2016.

The undersigned is please to convey the formal approval of the Government under Section-2 of the Forest (Conservation) Act. 1980 subject to following conditions.

- 1) The permission granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- 2) The forest land shall not be used for any purpose other than that specified in the FCA proposal.
- 3) The user Agency will have to obtain permission from this office for carrying out any maintenance works in future.
- 4) The user Agency will have to make good the forest land after use / maintenance work. **No tree shall be cut.**
- 5) The User Agency will be liable to make good any loss to Forests / Environment caused due to the use of the said land by the user agency.
- 6) The User Agency will seek permission from the Roads & Buildings Department / Science and Technology Department. Sachivalaya, Gandhinagar.
- 7) The Optical Fiber cable line will be laid underground in a trench depth of 2 mtr. and width of 0.45mtr. in between rows of road side plantation.
- 8) Any other condition which the Nodal Officer (FCA) may stipulate from time to time.
