TO WHOM SO EVER IT MAY CONCERN

In compliance of the Ministry of Environment and Forest (MOEF) Government of India's letter No. 9/98-FC (pt.) dated 2nd August 2009 wherein the MOEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006 (FRA, for short) on the forest land proposed to be diverted for non forest purposes, it is certified that **0.91.55 hectares** of forest land proposed to be diverted in favour of HPPWD for the construction of **Helipad in Kee** (purpose for diversion of forest land) in Lahaul & Spiti District falls within jurisdiction of Gram Sabha Kee in Tehsil Spiti at Kaza Distt. Lahaul & Spiti.

It is further certified that:-

- a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire **0.91.55 hectares** of forest land proposed for diversion. A copy of records of all consultation and meeting of the Forest Rights Committees (s), Gram Sabha (s), Sub Division level Committee(s) and District level Committee are enclosed as **annexure A-1 to A-4 annexure**
- b) The proposal for such diversion (with full details of the project and its implications, in Hindi / local language) has been placed before each concerned Gram Sabha of forest-dwellers, who are eligible under the FRA.
- c) The each of concerned Gram Sabha(s), has certified that all formalities/processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and compensation and ameliorative measures, if any having understood the purpose and detail of proposed diversion. A copy of certificate issued by the Gram Sabha Kee village is enclosed as **annexure B-1**.
- d) The discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present.
- e) The diversion of forest land for facilities managed by Government as required under section 3(2) of FRA have been completed and the Gram Sabhas have given consent to it.
- f) The rights of Primitive tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3 (i) (e) of the FRA.

Proceedings of the meeting of Sub Divisional Level Committee (SDLC) on The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 convened on 12th October, 2018 under the Chairmanship of Sh. Jeewan Singh, SDO (Civil), Kaza-Cum- Chairman, SDLC, Kaza.

At the very outset, Member Secretary welcomed all members and officers and thereafter with the due permission of the Chair started the proceedings of the meeting.

Review of the SDLC Meeting dated 4th June, 2018:- The Member Secretary apprised that the requisite information on the prescribed perfroma has not been received from the Nodal Officer/Department i.e Block Development Officer, Kaza. It is therefore decided that Block Development Officer, Kaza may be requested again to furnish the same immediately so that it can be forwarded to the DLC/SLMC.


Agenda No. 2:

Issuance of the certificate (s) for various developmental works under the provisions of The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006:- The Member Secretary said that various department like PWD, Tourism and Agriculture has applied for the issuance of the FRA certificate under said Act, detail annexed at **Annexure A**. The SDLC perused all the proposal of the departments and scrutinized the Annexure I, II and V issued by the FRC/Gram Sabha (Muhul

Sabha) in each case and satisfied that all cases are eligible for issuance of the FRA certificate at SDLC level. Therefore, SDLC unanimously decided to issue the Annexure III in all case and submit the cases to the DLC for consideration and issuance of FRA certificate. Annexure I, II (in duplicate) and Annexure V (in original) along with the copy of the proceeding of the meeting of concerned FRCs, Gram Sabha (Muhai Sabha) and SDLC are attached with each case.

Agenda No. 3:

Reconsideration of the five individual claims remanded back by the DLC:- The Member Secretary apprised the SDLC that five individual cases under FRA, forwarded to DLC for consideration and issuance of the title has been remanded back to SDLC for re- inspection and completion of the formalities vide letter No. 1843 SK (Establishment) dated 10.10.2017 of the Deputy Commissioner, Lahaul & Spiti- Cum- Chairman, DLC, received in this office on dated 16.05.2018. In the SDLC meeting dated 04.06.2018, aforesaid cases were reconsidered, and it was decided to remand back all cases to concerned FRC/Gram Sabha (Muhai Sabha) and concerned FRC/ Gram Sabha has now submitted the all cases after doing needful to this office. Details of the aforesaid mentioned individual case are being annexed as **Annexure B**. It is deliberated that out of five claims, two claims under FRA are pending for adjudication before Ld. Collector, Forest and in rest three FIR has been registered and Challenged, which are pending adjudication before the Ld. Court of CJM, Kinnaur. The DFO (WL), who is also the member of the SDLC suggested that the aforesaid mentioned cases may not be recommended for issuance of the title under FRA and as such SDLC may seek the directions / clarification from the DLC. The suggestion of the Ld. member is agreed upon and it is decided to forward the cases to the DLC for its consideration only. However, it is pertinent to mention here that as per the provisions of the Section 5 of The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, "no



members of the forest dwellers Scheduled Tribe or other traditional forest dweller shall be evicted or removed from the forest land under his occupation till the recognition and verification procedure is complete".

Agenda No. 4:-


Consideration and decision on the individual claims submitted before SDLC:- The Member Secretary said that 30 individual claims duly recommended by the concerned FRCs and Gram Sabha (Muhai Sabha) has been received for consideration before the SDLC, details annexed as **Annexure C**. Out of aforesaid 30 individual claims, claims at Sr No. 28 to 30 are either under trial before Ld Collector Forest or before Ld. CJM, Kinnaur, hence submitted for consideration only. After thoughtful deliberations on all the claims, it is decided by the SDLC that remaining 27 individual claims from Sr No. 1 to Sr No 27 qualify for the consideration before DLC and it is therefore recommended. The clarification as to the "primarily resided in the forests or forest land" and "bonafide livelihood needs" has been thoroughly deliberated upon. In this regard, Govt. of India, Ministry of Tribal Affairs vide circular No. 17014/02/2007-PCNV Vol. VII dated 09.06.2008 has clarified that "the implication of using the word primarily is to include the Scheduled Tribes and Other Traditional Forest Dwellers, who have either habitation, or patches of land for self-cultivation for livelihood, and would, therefore, be primarily spending most of their time either in temporary makeshift structures or working on patches of land in such areas irrespective of whether their dwelling houses are outside the forest or forest land. Therefore, such Scheduled Tribes and Other Traditional Forest Dwellers, who are not necessarily residing inside the forest but are depending on the forest for their bonafide livelihood needs would be covered under the definition of forest dwelling Scheduled Tribes and Other Traditional Forest Dwellers as given in Section 2 (c) and 2 (o) of The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006."
