Further, it is to inform that the Principal Chief Conservator of Forests, Andhra Pradesh, Hyderabad issued instructions for collection of the Net Present Value amount.

An area of 0.490 Ha. of Forest land is to be diverted in the Protected Forest Land in Odalarevu village of Kakinada division for laying of 14" dia Duel pipeline & umbilical from landfall point to onshore Terminal at Odalarevu (V) of Allavaram Mandal for development of Vashista and S:1 Development project of Eastern Off Shore Asset, ONGC Kakinada.
