It is proposed to take up for Improvements to Rechapally to Thatlawai road from km 3/0 to 10/0 in Karimnagar District. From Km 7/0 -10/0 The Government have accorded administrative sanction for an amount of Rs.2.10 Crores vide reference 1st cited.

This road length is 5.792 Km single lane with earthen surface. Hence it is required to improve it to the all weather road by proposing WMM and Bituminous concrete in addition to constructing C.D works, wherever necessary to have proper transportation facilities to the villagers.

The entire road is passing through forest reach from Km.3/0 to 10/0 both sides. The above forest reach is under the forest jurisdiction of Karimnagar West Division.

The Telangana State Government have taken a policy decision to improve the interior roads to R&B standards. The Government have accorded administrative sanction for an amount of Rs.2.10 Crores vide TS Memo No13/NABARD-RDF-XX/2015-16 Dt;24-4-2015. Due to improving the above road, further connectivity in terms of achieving smooth and safe traffic flow and with higher level of service. In addition to the above, substantial economic gain in terms of reduced Vehicle Operating Cost (VOC) and reduced travel time will be achieved.

It is proposed to take up road construction on the existing road. As such the permission of the authorities is required. Hence proposal is submitted for diversion of forest land worked to an extent of 11.584 Hectares in Karimnagar West Division.

A detailed Differential Global Position Survey is carried out in the above reach along with the forest section officers. As per our requirement the total extent of forest land is arrived as 11.584 Hectares in Jurisdiction of Karimnagar Forest West Division, for which linear diversion of forest land is required.

The proposals are being submitted as per the guidelines issued under Forest (Conservation) Act 1980, the project for road construction will be processed in their entirety. Hence, the proposals for Acquisition of forest land is prepared in the Karimnagar ^{West} ~~East~~ forest Division in the prescribed format, drawing showing the improvements, Longitudinal section and cross section along with forest map showing the area of land are herewith enclosed for kind perusal. Hence, I herewith submit the proposals under Forest (Conservation) Act, 1980 with the following enclosures.

It is, therefore, requested to arrange to initiate the process of forest land acquisition and also required to pass necessary orders to the concerned to start the field survey as early as possible for submitting same to the Government for according approval of linear diversion of forest land for geometrical improvements of road in reserve forest.

In this connection, it is submitted that the district collector, Karimnagar was addressed for allotment of Compensatory afforestation land vide this office letter no Forest CA/TS/SEK/2016/389 dated 25.02.2016 for diversion of forest land to non forestry purpose. (Copy of the same is here with enclosed)

The ROFR certificate issued by the District Collector along with the enclosures shall be obtained and furnished to the DFO, Karimnagar West Division, for processing.
