07.09.2013 has requested all the collectors to issue the certificate required under the provisions of Forest Right Act 2006 expeditiously-kindly refer Annexure-III

As you are aware Sir, looking to the importance of the matter of issuance of certificate without loss of time even the revenue Dept.in a fax message No.PRC/102014/1109/GH dated 03.06.2015 as Annexure -IV addressed to all the collectors has requested to issue the certificate as early as possible.

In this fax message they have also clarified that when the proposal of diversion of protected forest along the highway is considered by the government the land if this state highway are acquired by the state government under the provisions of the land acquisition is act 1894 and the possession of the said land are obtained and the compensation is paid such lands vests Government and therefore such certificate should be issued as early as possible.
