2.	Short narrative of the proposal and Project/scheme for which the forest land is required	<p>Development of Greenfield International Airport at Mopa in Goa is presently in progress and phase I of the airport is expected to be commissioned in the year 2022. The project is being implemented in 4 phases with passenger handling capacity of 4.4 million passengers per annum (mppa) in phase I followed by 5.8 mppa, 9.4 mppa and 13.1 mppa in phase II, phase III and phase IV respectively. The airport has an ultimate potential of over 30 mppa.</p> <p>Presently, the proposed airport is connected with a village road. As the airport becomes operational there will be manifold increase in movement of traffic both passenger and cargo. Therefore, the airport needs to be connected with a dedicated approach road for seamless movement of traffic.</p> <p>In view of above, it is proposed to connect the airport to the nearest National Highway with a six-lane access control expressway at a length of 6.5 kms. The Mopa Airport project has received Environmental Clearance (EC) from Ministry of Environment, Forest and Climate Change vide letter No. F.No.10-29/2011-IA.III dated 28th October 2015 and Addendum No. F. No. 10-29/2011-IA-III dated 13th March 2020. This EC includes the approach road connectivity to the airport mentioned above.</p> <p>The total land area of the proposed approach road is 4,10,270 sq mtrs, of which non forest involved is 3,81,387 sqm and private forest area is 28,883 sqm. The construction of the proposed approach road (expressway) to Mopa Airport is crucial and time bound as it is necessary to commission the same to coincide with the commissioning of the airport in the year 2022.</p>
