BRIEF NOTE

NOC has been applied in the office of Deputy Commissioner Patiala for installation of Retail Outlet of IOCL at Vill: Dhanetha, Tehsil Samana, Disitt: Patiala on Retgarh - Shutrana Link Road Km 4 - 5 L/S.

The installation of IOCL Retail Outlet (Kisan Sewa Kendra) at Dhanetha will cater to the Retgarh Shutrana stretch. From Retgarh to Dhanetha the distance is around 5 kms and from Dhanetha to Nanhera the distance is around 7 kms. Presently there is no Retail Outlet in this stretch of 12 kms. Installation of Retail Outlet will facilitate the agriculturist, commission agents and general public who now travel to Retgarh or Nanhera for their fuelling needs.
