

KULDA EXPANSION PROJECT(PH-II)

REHABILITATION AND RESETTLEMENT PLAN

The land belonging to village Kulda, Bankibahal, Balinga, Tumulia, Siarmal and Lalma RF of Hemgir Tahasil, District Sundargarh, Odisha are involved in Kulda Expansion Project (Ph.II). The Kulda Expansion Project (Ph.II) includes the Mining Area, Safety Zone and Infrastructural Area.

Total 284.10 Ha (702.02 acres) of land is involved in Kulda Expansion Project(Ph-II). Out of which 94.92 Ha. is tenancy land, 54.49 Ha. GNF land and 134.69 Ha. is Revenue forest and Reserved forest.

Out of 94.92 Ha. of tenancy land involved in this Expansion project, 44.15 Ha. (109.09 acres) belongs to village Kulda, 20.90 Ha. (51.64 acres) belongs to village Bankibahal, 1.15 Ha. (2.83 acres) belongs to village Balinga, 28.73 Ha. (70.99 acres) belongs to village Tumulia. The land of above villages have been acquired under CBA (A&D) Act, 1957 vide notification u/s. 9(1) of said Act vide SO No.3055 dated 29.10.1990 and vested with MCL u/s. 11 (1) of the said Act vide SO No.43015 dated 30.03.1993.

The payment of Compensation for the village Kulda, Bankibahal, Balinga and Tumulia including other 10 villages have been under taken by the Claims Commission, set up by the Hon'ble Supreme Court of India in SLP© 6933 of 2007. The compensation for land and structures for village Kulda, Bankibahal, Balinga, has been disbursed to the beneficiaries and for

village Tumulia approval of Hon'ble Supreme Court is awaited to provide land compensation as well as R&R benefits.

Rehabilitation and Resettlement benefits to the affected families of village Bankibahal and Baling have been provided under Orissa R&R Policy 1998 & for the rest of villages i.e. Kulda, Tumulia, left out cases of village Bankibahal & Balinga has been undertaken under Orissa R&R Policy 2006.

On the recommendation of the Hon'ble Claims Commission and approval of the Hon'ble Supreme Court the R&R benefits has been provided to the villagers of Kulda and left out cases of village Bankibahal and Balinga. However after approval of the PAF list and Compensation roll of village Tumulia by Hon'ble Supreme Court the benefits will be provided to the villagers.

The following benefits will be extended to the affected families due to expansion of Kulda Project. The details are as follows:

Hon'ble Claims Commission has recommended to adopt the R&R Policy 2006, Govt. of Odisha accordingly the scheme for resettlement of MCL's is given below:

The displaced families of village Kulda & Siarmal who will not choose for self re-location will be resettled at Chhatenpali RR site. In Sarangijharia village, 88.00 acres of Govt. non forest land has been taken on lease by MCL to resettled the villagers of Gopalpur. In village Badkhalia 55.44 acres have been purchased from private owners for establishment of re-settlement site.

The re-settlement site for village **Tumulia** will be decided after approval of PAF list by the Hon'ble Supreme Court.
