CERTIFICATE

- a) It is certified that the process for ascertainment of forest rights/claims under Scheduled Tribes and other forest Dwellers Act, 2006 over the 8.55 Ha of land which is falling under Simong and Gobuk Gram Panchayats under Yingkiong Sub-Division of Upper Siang District are required for constructions of Yammeng HEP(20MW) being developed by M/s Yammeng Green Energy Private Limited has been completed. Further, fishing rights of the affected persons over the river bed area shall be continued. Therefore the process for ascertainment of Forest rights/calims of the individual/ communities under FRA over the 8.55 Ha of land has been completed. The resolutions passed by the Gram Sabha of Simong and Gram Panchayats under Yingkiong Sub Division of Upper Siang District were thoroughly examined and verified by the DLC and found in order, same enclosed here with.
- b) It is certified that the proposal for diversion of 8.55 ha of land for Yammeng HEP (20 MW) falling within the Simong and Gobuk Gram Panchayats under Yingkiong Sub Division of Upper Siang District were put forward before the Anchal Samiti/Gram Sabha of concern Gram Panchayats. It is further certified that the full details of the Yammeng HEP(20 MW) proposal and process for ascertainment of rights/claims of Communities/individuals over 8.55 Ha of land for diversion was described to Villagers in the Vernacular language. Purpose of the meetings and procedures were explained to the persons in vernacular language. Detailed discussion regarding forest rights over 8.55 Ha of land was carried out in Vernacular language in the meetings. The Gram Sabha meetings were conducted in free, open and fair manner and as per the provision of law.
- c) It is certified that three months notice period in the form of public notice was given to receive the claims, hence reasonable opportunity and time was provided to all interested individuals/parties to put forward their views/claims.
- d) It is certified that more than 78% of the villagers of concerned affected Gram Panchayats of Simong and Gobuk under Yingkiong Sub-Division of Upper Siang District were present in the meeting and actively participated in the discussion and same was recorded in the resolution. Gram Sabha was conducted in a free, Open and fair manner with requisite quorum. All the villagers were given same opportunity to register their claims, if any. Villagers of concerned Gram Sabha Panchayats have given their consent to the diversion of land for construction of Yammeng HEP(20MW).
- e) It is certified that all the Gram Sabhas in its meeting has recognized the right under FRA, the rights of which would be settled by District Administration as per the prevailing norms/laws. Rights identified by the Gram Sabhas are ownerships rights over the community land/individual land with forest cover and traditional rights for collection,use and disposal of minor forest produce over forest land. Further it is resolved that fishing rights,if any effected people shall be continued. The details of recognized claims/rights and persons are given with respective Gram Sabhas. Further no appeal/grievances has been filed against Gram Sabhas to District Level Committee within a stipulated time frame.

- f) It is Certified No Other traditional Forest Dwellers(OTFD) is present/settled/dwelling in the concerned Gram Sabhas of Simong and Gobuk Gram Panchayats under Yingkiong Sub-Division in Upper Siang District of Arunachal Pradesh.
- g) It is certified that no Villager is being evicted or displaced due to diversion of forest land required for construction proposed Yammeng HEP(20 MW) falling under Simong and Gobuk Gram Panchayats under Yingkiong Sub-Division of Upper Siang District.
- h) It is certified that the persons of concerned Gram Panchayats agree with the project proposal and have given their consent to the diversion of land for construction of Yammeng HEP(20 MW) by M/s Yammeng Green Energy Private Limited. Villagers have also given their consent for settlement of recognized rights by District Administration as per prevailing norms/laws.
- i) It is certified that section 3(2) of Scheduled Tribes and other Traditional Forest Dwellers Act, 2006 is not applicable for the present proposal as the project is not being managed by the Government nor the Project activity covered in the list of activities mentioned in section 3(2) of said Act.
- j) It is certified that Section 3(1) (e) of Scheduled Tribes and Other Forest Dwellers Act,2006 is not applicable for the present proposal, as there is no Primitive Tribal Groups/ or Pre Agriculture Communities in the Project area of Yammeng HEP (20 MW) in Upper Siang District of Arunachal Pradesh.
- k) It is certified that process for ascertainment of forest right/claims of individuals/Communities under FRA over 8.55 Ha of land which is falling under Simong and Gobuk Gram Panchayats under Yingkiong Sub-Division in Upper Siang District of Arunachal Pradesh for construction of Yammeng HEP(20 MW) being developed in M/s Yammeng Green Energy Private Limited has been completed in accordance with Schedule Tribes and Other Traditional Forest Dwellers Act, 2006. Forest Rights over the said land of 8.55Ha including fishing rights over river bed had been recognized by the respective Gram Sabhas and same were verified and certified by DLC.

GRAM SABHA RESOLUTION/MINUTES OF MEETING OF GRAM SABHA OF SIMONG GRAM PANCHAYAT.

In order to implement the process for settlement of forest rights over 8.5542 ha. of forest land (i.e. community land with forest cover) Simong village required for construction of 20 MW Yammeng Hydro Project, a meeting of Gram Sabha (GS) of persons belonging to Simong East/Simong West-I and Simong West-II Gram Panchayat (GP), was held in the presence of member secretary Simong Gram Panchayat, forest officials, GB/GS chairman, Simong and representatives of Yammeng Green Energy Pvt. Ltd on 15/06/2016 at 1000 hrs. at Simong village District Upper Siang.

Purpose of Gram sabha meeting, process for ascertainment of the claims/right of the person having rights over forest land as well as details of 8.5542 ha. of forest land as well as details of 8.5542 ha. of forest land falling under old habitation of Simong Gram Panchayat, were briefed to the person in local vernacular language also. Detail information related to project features of 20 MW Yammeng Green Energy Pvt. Ltd were explained by the representative of the Power Developer during the meeting.

Notice for inviting claims and calling for meeting of Gram sabha GS under Simong Gram Panchayat, was issued on 11th March, 2016 providing three months time period and the same were also published in news papers vis-à-vis Eastern Sentinel (English) dated 22.03.2016, Arunachal Front dated 22.03.2016, the Dawn lit Post dated 02.04.2016, the Arunachal Times dated 02.04.2016 and local language (Adi) respectively. Therefore, appropriate publicity regarding Gram Sabha meeting i.e. venue, time, place etc was done in form of public Notices, News paper etc to the all the interested individuals/parties.

In the said meeting detailed discussion regarding individual/community holding over 8.5542 ha. of community land with forest cover falling under Simong East /Simong west-I and Simong West-II Gram Panchayat, which is required for construction of 20 MW Yammeng Green Energy Pvt. Ltd as detailed in the enclosures of the notice for the meeting was carried out in vernacular language. It was noted that no person is being evicted or displaced due to construction of Yammeng Green Energy Pvt. Ltd in the old habitation of Simong

After detailed discussions, the Gram sabha comprising of person belong to Simong village passed following point wise resolution:-

- (1) The meeting was conducted in a free, open and fair manner. The purpose of meeting and procedures were explained to the persons in vernacular language. Three months notices period in the form of public notices/News papers was given to receive the claims; hence reasonable opportunity and time was provided to all interested individuals/parties to put forward their views/claims.

- (2) More than 66% of persons belonging to **Simong** were present in the meeting and actively participated in discussions. **Simong** is an old habitation and become depopulated as residents had migrated to the adjoining plain areas of **Yingkiang Circle**, however their land holding remains there.
- (3) During the public notice period, No claims were received by the member Secretary of **Simong Gram Panchayat**, in respect of **8.5542 ha.** Land falling under **Simong**.
- (4) It is also resolved that fishing rights, if any of the affected persons shall be continued.
- (5) No other person except above said _____ Nos. of persons have any forest rights/claims under the **FRA, 2006** over the over **8.5542 ha.** of land proposed for diversion under old habitation of **Simong East /Simong west-I and Simong West-II Gram Panchayat,**.
- (6) The persons agree with the said proposal under **FRA, 2006** for diversion of **8.5542 ha.** of community land with forest cover for construction of **20 MW Yammeng Green Energy Pvt. Ltd.** from their village/habitation **Simong East /Simong west-I and Simong West-II Gram Panchayat,**.
- (7) The process/formalities of **FRA** have been completed and eligible persons belonging to the old habitation **Simong Gram Panchayat**, have given their consent to the diversion of **8.5542 ha.** of community land with forest cover for the construction of **20 MW Yammeng Green Energy Pvt. Ltd.**
- (8) No other traditional forest Dwellers (**OTFD**) are present in the **Simong** village Details of member of **GS** of old habitation of **Simong East /Simong west-I and Simong West-II Gram Panchayat**, present in the meeting along with the signature of eligible persons recognized under **FRA** are as follows:-
