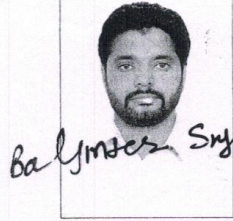

Please be informed that by this Letter of Intent, we propose to offer you a Retail outlet dealership of Indian Oil Corporation Limited at the above location on the following terms & conditions:-

1. You have offered a suitable piece of land admeasuring 35 meters approx. (frontage) x 35 meters (depth) at Khewat/Khatauni No. 677/1128 Khasara no. 83//14/1 Min. (2-11) indicated by you in the application for the development of the subject Retail Outlet. You have to make available this land within 2 months from the date of this letter failing which this offer is liable to be withdrawn.
2. For making the land available as required above, you will ensure that the land arranged by you is either registered in your name or it should be leased to you for a minimum period of 20 years.
3.
