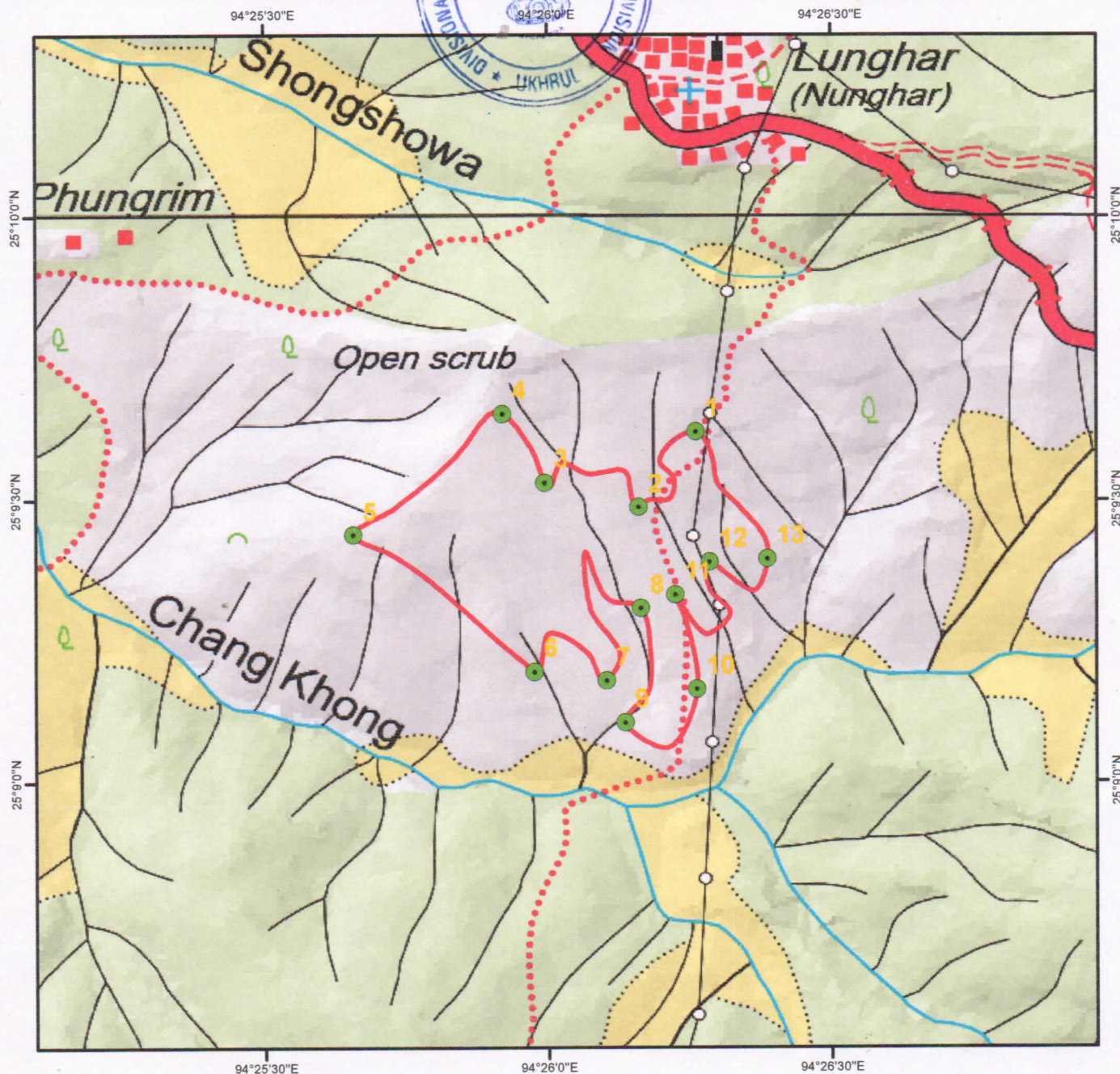


**MAP SHOWING PROPOSED CA PLANTATION SITE

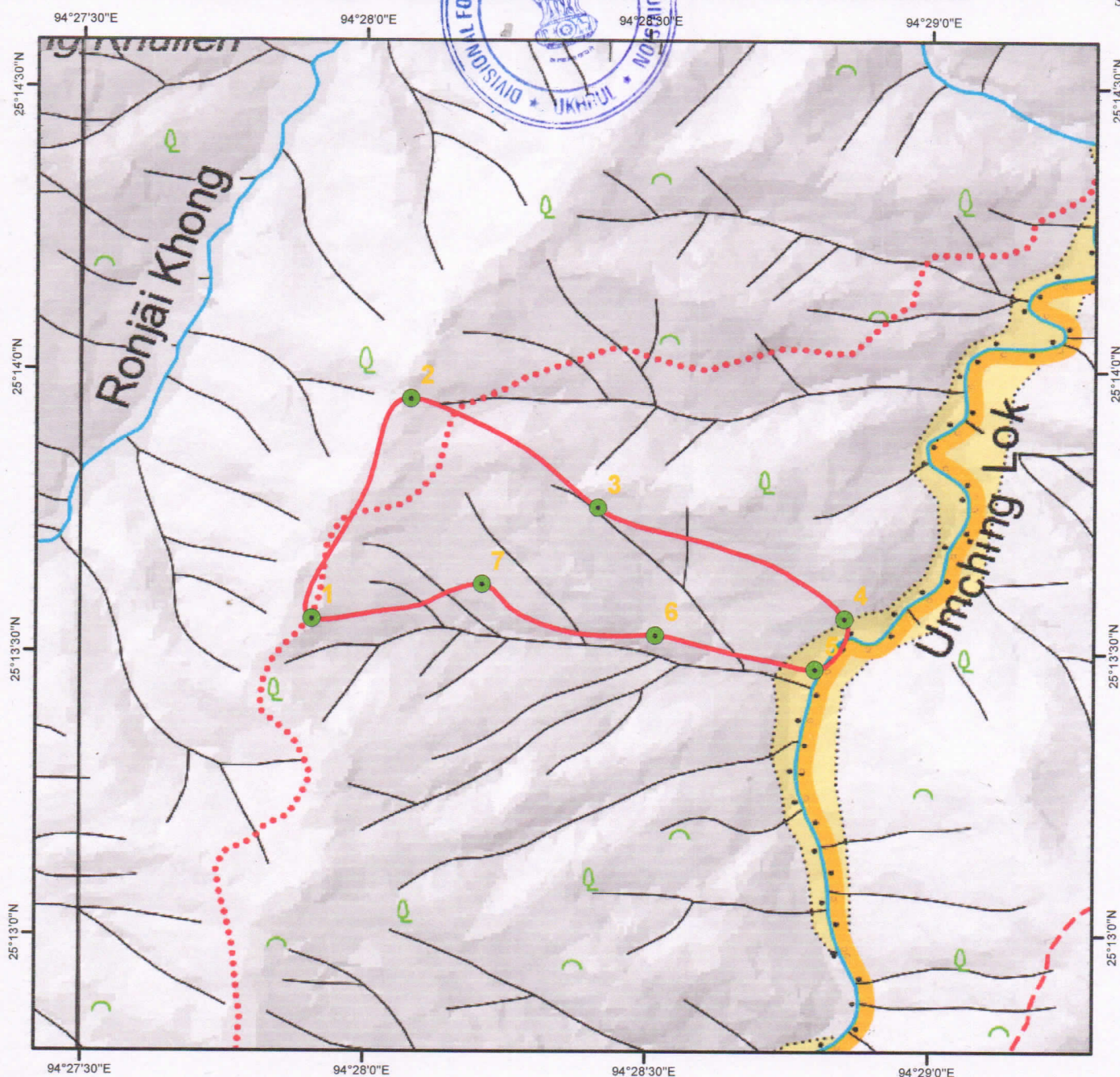
