With reference to the Stage I approval order Compensatory Afforestation scheme was technically approved @Rs.213.50/- mandays. The user Agency has furnished an undertaking to pay entire amount of compensatory Afforestation in lieu of the forest area diverted for additional spillway of Hirakud Dam as per prevailing wage rate at the time of plantation. Now herewith find the revised financial outlay with detailed cost break up for the approved C.A in triplicate at the current wage rate of Rs.280/- per manday for necessary action at your end.






