It is informed that the Government of Andhra Pradesh in MoEF, C.C. Rc.No.4-APB19/2016-CHN/2152, dt: 01.11.2016 have accorded in-principal Stage-I approval for diversion of 4.42 hector for Excavation of Tunnel under Tharakarama Thirtha Sagaram Reservoir project land in Damarasingi R.F., of Vizianagaram Division in favour of Executive Engineer, T.R.T.S., Vizianagaram.

In this connection, it is informed that the compliance wise condition reort for the stage-I approval was submitted to the Chief Conservator of Forests, Visakhapatnam in the reference 7th cited. However the Government of India vide condition No.6 have instructed to revise the C.A., scheme which includes fencing of Non Forest land. Accordingly the C.A., scheme was revised duly included the fencing to the Non Forest land and arrived for Rs.24.94 lakhs.

Hence, it is requested to pay the balance cost of C.A., scheme of **Rs.6.75 lakhs** (Total revised C.A., = Rs. **24.94 lakhs**, amount paid by the user agency = Rs.**18.19 lakhs**, balance to be paid = Rs.**6.75 lakhs**) to the A.P. Forest Department. The balance amount of Rs.6.75 lakhs should be paid through online challan as per the procedure adopted by the user agency while making payment of N.P.V., and C.A., to the Forest Department in the earlier. The payment details of balance C.A., scheme may please be furnished to this office for taking further action.
