As per condition No. ix (part) of Government of India, MoEF and Climate Change, New Delhi vide No. 8-17/2016-FC dt 12.09.2017, the User Agency has to pay the cost to carry out 1.5 times Safety Zone Plantation Scheme. The Field Director, Similipal Tiger Reserve-cum-Regional Chief Conservator of Forests, Baripada Circle, Baripada has approved the 1.5 times Safety Zone Plantation Scheme amounting Rs. 11,99,589.00 (Rupees Eleven lakh ninety-nine thousand five hundred eighty-nine) only.
