I invite your attention to the subject and reference cited above. The Government of Telangana have accorded in-principle (stage-I) approval vide reference 1st cited above for Diversion of **3.964 Ha** of forest land in Kothagudem(1.164 Ha), Paloncha (0.616 Ha) and Sathupally (2.184 Ha) forest divisions under Kothagudem and Khammam Districts – For laying of pipe line and Construction of Structures for **Segment-25/13 (Ramachandraram)** for providing safe drinking water under Telangana Drinking Water Supply Project infavour of Superintending Engineer, TDWSP (RWS&S) Circle, Khammam.

In this regard, the Principal Chief Conservator of Forests, TS, Hyderabad vide reference 2nd cited above has issued instructions to raise the Demand with the User Agency after vetting of the Demand note by Nodal Officer. Hence, the Demand notice has been prepared and submitted to the Additional Principal Chief Conservator of Forests (FCA), TS, Hyderabad in the reference 3rd cited above.
