<u>Profile of Liebherr CMCtec India Private Limited</u> (Maharashtra,India)

The Liebherr Group decided to setup a manufacturing unit in India and on 7th January 2008 Liebherr CMCtec GmbH through its spearheading Company in Germany namely LIEBHERR-Mischtechik GmbH and Liebherr-Werk Biberach GmbH formed- LIEBHERR CMCtec India Private Limited to setup a Green field Project for manufacture of construction equipment's in India at Pune with special stress on technology and cranes.

As India is on the way to becoming one of the world's largest markets for tower cranes. In order to satisfy this demand, Liebherr CMCtec India Private Limited started the production of tower cranes on stream in Pune in at the beginning of 2012 which will bring Liebherr crane technology and supply construction tower cranes in India

Employment Generation

From the inception of the company the approximately 500 employments was generated on various fronts on behalf of the company and contractor. Approximately 100 vendors were developed to cater various needs of the company.

At present due to unforseen circumstances the employment generation has gone down to approximately 119.

Various Taxes Paid to Govt. Authorities.

- 1) Non Agricultural tax Paid to Tahsil Rs. 11,75,040/-(Rupees Eleven Lac Seventy Five Thousand and forty only) (Rs.1,95,840/- x 6 years) paid from April 2009 to March 2015.
- 2) Property Tax Paid to Grampanchayat Rs.42,00,000/- (Rupees Forty Two Lacs) paid from April 2009 to March 2015.

Short Narrative of the proposal for seeking approval under section 2 of Forest (Conservation) Act,1980

M/s Liebherr CMCtec India Private limited has purchased a land bearing Gat no.460 461,462 and 463 of 54 acres in a peaceful location of village Dhagudewadi, Taluka: Daund, District: Pune 412203 on **17**th **November 2008**.

The following necessary permissions from various governments authorities were obtained to establish and operate a manufacturing setup at the said location;

- 1) No objection Certificate from Baramati Sub-Divisional Office of the Collector Office, Pune for Non Agricultural Zone approved on vide no.NA/SR/176/2009 dated 5th September 2009.
- 2) Approval provided by the Town Planning Department of Baramati Sub-Divisional Office vide no636/11 for development of land.
- 3) Approval provided by the Addl.Directorate of Safety and Health, Pune vide letter no.4105 dated 05.11.2011 and 12.05.2014.(License no100368 dated 29.12.2011).
- 4) Consent to Establish and Operate from Maharashtra Pollution Control Board, Pune vide no BO/CAC-Cell/EIC No.PN 21398 and BO/JD/APC/EIC.PN-12180

Company had constructed road of 1114 metre in (length) and 12 metre in (width) from old Shirur – Satara road to have access to its premisis thru shiv road between village Boropardhi-Deulgaonwada and expanded the width of the road by undergoing the Right of Easement with various local farmers.

On <u>05.07.2009</u> the land bearing survey number 464 was handed over from Revenue department to forest department and company was not aware of these changes among the departments, further till the completion of road none of the objections was raised by authorities.

Taking into consideration the geographical condtions of the surrounding area, the company was land locked from all sides due to above new changes.

On 09.08.2012 the offence was registered against the company by forest department vide no. ATTI/3/201213 and the activities of the company sufferred drastically.

Proposal for the Access Road.

Out of existing road of 1114 metre in (length) and 12 metre in (width) ,110 meter in (length) and 12 metre in (Width) was passing through Gat no.464 belonging to the Revenue Department, Pune.

After working on all possible practically alternatives, there is no access to reach the company land without passing through the land bearing Gat No. 464 belonging to forest department (which has come under their juricdiction from 05.07.2009) and fruther there was no alternative non-forest land available for this purpose it is impossible to avoid the forest land.

Due to non availability of non forest land we are submiting the proposal for obtaing clearance from forest department.

Company had tried all alternatives for this purpose but it is not possible to avoid the forest land. It is unavoidable, as there is no alternative non forest land available for this purpose and the required land is reserved forest land.

JUSTIFICATION

The other all possible alternatives were examined by us. It is not possible to implement the proposed project without avoiding the forest areas in Forest Gat No. 464 of village Dhaygudewadi, Taluka Daund, District Pune. The forest area demanded is the barest minimum and immediate requirement for the project and there is no alternative non forest land available for this purpose.


