TO WHOM SO EVER IT MAY CONCERN

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No-11-9/98-FC(pt.) dated 3rd August, 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition) of Forest Rights) Act, 2006 on the forest land proposed to be diverted for non-forest purpose, it is certified that **1.92.21 hectares** of forest land proposed to be diverted in favour of **District Youth & Sports Office Chamba GoHP** for the Construction of **Sports Stadium** falls within the jurisdiction of Mohal Jhanui in Tehsil Bhattiyat District Chamba.

It is further certified that: -

- a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire **1.92.21 hectares** of forest land proposed for diversion. A copy of records of all consultation and meetings of the Forest Rights Committee, Gram Sabha, Sub Division Level Committee and the District Level Committee are enclosed as annexure-I to annexure-IV.
- b) The proposal for such diversion (with full details of the project and its implication. In vernacular/Local language) have been placed before each concerned Gram Sabha of Forest-dwellers, who are eligible under FRA.
- c) The each of concerned Gram Sabha (s) has certified that all formalities/process under the FRA have been carried out and they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any having understood the purpose and details of proposed diversion. A copy of certificate issued by the Gram Sabha is enclosed as annexure I to annexure III
- d) The discussion and decision on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha (s) present.
- e) The diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gram Sabha (s) have given their consent to it.(NA)
- f) The rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3 (1) (e) of FRA.




