Enclosed, please find herewith the Stage-I/ in-principle order of Govt. of India, MoEF & CC, I.R.O, Bhubaneswar vide letter no. 5-ORC-441/2021-BHU dt. 04.02.2021 received from the Director-cum-Special Secretary to Govt., Forest & Environment Deptt., Govt. of Odisha for diversion of 13.22 Ha. of forest land for construction of Khurda Road-Bolangir New BG Rail Link Project Phase-IV i.e. 180 Km. to 238 Km. for which proposal was forwarded by this office vide memo no. 1458 dt. 29.03.2019 to R.C.C.F, Berhampur Circle for onward transmission to Govt. of India. The Stage-I approval referred to above indicates that Govt. of India MoEF & CC, agrees in-principle for diversion of 13.22 Ha. forest land for construction of Khurda Road-Bolangir New BG Rail Link Project Phase-IV i.e. 180 Km. to 238 Km. subject to compliance of conditions as laid down in Para-A (11 conditions) i.e. conditions which need to be complied prior to handing over of forest land by the State Forest Department and Para-B (21 conditions) i.e. conditions which need to be strictly complied on field after handing over of forest land to the User Agency by the State Forest Department, but the compliance in form of undertaking shall be submitted prior to Stage-II approval so as to consider the case for Stage-II (Final) forest clearance.

The Forest & Environment Department, Govt. of Odisha have imposed additional condition i.e. the User Agency shall take up Avenue Plantation on either side of alignment of the track at it's own cost in consultation with the DFO, Boudh.

The Chief Conservator of Forests, (Forest Diversion & Nodal Officer), FC Act O/o the Pr.C.C.F, Odisha, Bhubaneswar vide his memo no. 8036 dt. 16.04.2021 has directed to issue demand notice for all the compensatory levies to the User Agency for payment through web portal of MoEF & CC and submit the deposit particular (in prescribed CAMPA format) of the

amount to be paid pertaining to the above project and additional conditions imposed by the State Govt. vide letter under reference.

Accordingly, the following compensatory levies are demanded against you to deposit in the CAMPA Account of the State through (<https://parivesh.nic.in/>) and submit the deposit particular (in prescribed CAMPA format) to this office immediately for further action at this end. Additional compensatory levies, if any, shall be intimated in due course of time.




