It is to inform that, the Government of Andhra Pradesh in the reference 1st cited, have accorded stage-I approval for diversion of 3.28 ha. Forest land in Compartment No.s 12 & 191 in Vemularai and Vemularai Extn-I RFs, Lakkavaram Range of Chintur Division for formation and BT including construction of culverts to the road from ZP Road at Kothapally to Nelakota (V) in favour of Executive Engineer, PR(PIU) Division, Kakinada by duly stipulating certain conditions to be complied as communicated by the Prl. Chief Conservator of Forests, A.P., Guntur vide reference 2nd cited(copies enclosed).

Hence, the Executive Engineer, PR(PIU) Division, Kakinada is requested to go through the conditions stipulated from (i) to (ix) in the G.O.Ms.No.16 EFS & T(Section-II)Dept., Dt.14.02.2019 and also follow the instructions issued by the Prl. Chief Conservator of Forests, A.P., Guntur without any deviation and publish the entire forest clearance granted in verbatim along with the conditions and safe-guards imposed by the Central Government in two widely circulated daily news papers one in vernacular language and an other in English language so as to make people aware of permission granted to the project proponent for use of forest land for non forestry purposes. The copies of the Forest Clearance should also be submitted to the Heads of local bodies, Panchayats and Municipal Bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 Days.

Further, the following are the Compensatory levies to be paid by the User Agency through e-payment mode as per the guidelines issued by the Ad-hoc CAMPA, New Delhi letter dated: 09-06-2016 and the details are as follows:-

1.(a) Procedure for e- challan generation:

- On issue of this notice, the user agency shall log in to Forest Clearance portal **forests clearance.nic.in/www.parivesh.nic.in** to generate e-challan and make payment against the demand.
- Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- Once it is verified by Nodal Officer, Agency can generate e-challan from the portal

1.(b) Procedure for Payment through RTGS :

- For payment through RTGS, the representation of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.
- While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- Upon executing the RTGS by the sender/remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.




