
In inviting kind reference to the above cited memos on the above subject, it is to inform you that due to revision of wage rate from Rs. 303.40/- MD to 308/- MD, the financial outlay of Compensatory Afforestation has been revised from 40,37,900/- to 40,72,100/- which is technically approved by the Pr.CCF, Nodal, O/O the Pr.CCF, Odisha, Bhubaneswar .

As such it is requested to deposit the differential amount of Rs.34,200/-(40,72,100/- – 40,37,900/-) through the account of State CAMPA managed by the Ministry of Environment of Forests, immediately. Further you are requested to take immediate action to transfer 10.58 hect. of non-forest land in favour of Forest and Environment Department in consultation with the concerned Tahasildar and Revenue Authorities .

Besides above it is requested to further submit necessary undertaking as regards to Sl. A-VI, B-I, IV to XII, XIV to XVII of your letter No. AIIMS/BBSR/76/2021 dated 05.04.2021.

After receipt of the above the same shall be sent to the higher authorities for final approval.


