Note containing justification for locating the project in Forest Land

Introduction:

Indian Oil Corporation Limited (A Government of India Undertaking) is authorised for implementation of City Gas Distribution (CGD) projects. Indian Oil Corporation Limited (IOCL) has been granted an authorization by Petroleum and Natural Gas Regulatory Board (PNGRB) for laying building, operating and expanding City Gas Distribution Network & Compressed Natural Gas (CNG) Outlets in Geographical Area of Khagaria, Saharsa and Madhepura Districts vide authorization dated 29.03.2019.

Indian Oil Corporation Limited is implementing CGD projects in Geographical Area of Khagaria, Saharsa and Madhepura Districts along with various other cities of country under the Petroleum and Natural Gas Regulatory Board (Authorizing entities to Lay, Build, Operate or Expand City or Local Natural Gas Distribution Network) Regulation, 2008.

Justification:

This being a City Gas Distribution project, the Natural gas pipeline network will connect major demand centre in city for Domestic connection and to CNG retail Outlets. Natural Gas Pipelines has to be laid along the roads in the city. The network is starting from City Gate station and has to reach the city via shortest routes along the roads. In this particular case, steel pipeline route will originate from GAIL (IP-01), at Biri Ranpal, Udakishanganj, in Madhepura District and will traverse along the NH-106 (Udakishanganj to Madhepura district head quarter) in Madhepura District to reach Madhepura and then along NH-107 from Madhepura district head quarter to Saharsa in Saharsa district in the shortest possible manner. As NH-106 (Udakishanganj to Madhepura district head quarter) and NH-107 from Madhepura district head quarter to Saharsa in Saharsa district is under Protected Forest so the said proposal is required to be applied for permission. There is no other alternative to this section in city reaching the Madhepura district head quarter and then Saharsa the said proposal is required to be applied for city and residential colonies.

Certificate for Non-availability of Alternate Land for CGD Project in Madhepura and Saharsa Districts

IndianOil Corporation Limited is implementing City Gas Distribution project in Madhepura and Saharsa districts under which steel network and MDPE network is to be developed along the roads in Madhepura and Saharsa districts. Steel pipeline route will originate from GAIL IP-01, at Village Biri Ranpal, Udakishanganj in Madhepura District and will traverse along the NH-106 to reach Madhepura district headquarter and then along NH-107 it will be extended up to Saharsa district.

33.249 km of steel network along NH-106 (Udakishanganj to Madhepura) and 20.933 km steel network along NH-107 (Madhepura district headquarter to Saharsa) are envisaged to be laid along the NH which are falling under protected forest as per schedule.

The pipeline will feed to CNG outlets and PNG connections to demand centers in the city/town of Madhepura and Saharsa districts by utilizing minimum forest area in shortest route.

It is hereby certified that there is no alternate land available other than proposed forest land for laying/construction of CGD natural gas pipeline.
