The line between Itarsi-Nagpur passes through Hoshangabad, Chhindwara, Betul districts of Madhya Pradesh and Nagpur District of Maharashtra. The electrified double line section between Km. 750+000 at Jujharpur to Km.792+650 at Dodharamohor is serving passengers as well as goods traffic. In order to cope with increased demand for both passenger and goods traffic, the Government of India has decided to augment the carrying capacity by developing third line for the said section. **Central Railway (CR), Nagpur Division** is the implementing agency for the proposed 3rd railway line between Itarsi to Nagpur stations for the section between Jujharpur (Km.750+00) and Dodharamohor (Km.792+650).
