With reference to the subject cited, it is to submit that vide reference 9th cited, the Government of India, Ministry of Environment, Forest and Climate Change, Hyderabad, Telangana has Stage-I (in-principle) approval for Diversion of 4.4824 Ha of forest land in Siddipet forest division for erection of 220 kv DC line from 400/220/132 KV Gajwel SS to 220/132 KV Siddipet SS in Medak District in favour of Executive Engineer, Construction, TS, TRANSCO, Sangareddy.

Vide reference 10th cited, the Prl. Chief Conservator of Forests, TS, Hyderabad has requested to issue the demand notice to the User Agency in consultation with Nodal Officer for Forests (Conservation) Act, 1980 for payment of compensatory levies like Net Present Value, compensatory Afforestation, protection structures Etc., only after vetting by the Nodal Officer, the demand shall be raised, and also requested to obtain the compliance report on the conditions stipulated in Stage-I (in-principle) approval from the user Agency and furnish for obtaining Stage II (final) approval from Government of India.

Accordingly, a demand notice is prepared and the following are the amounts to be deposited by the User Agency:

It is further submitted that the Executive Engineer, Construction, TS, TRANSCO, Sangareddy is requested to upload the Demand Notice at Ministry's portal i.e., <http://parivesh.nic.in/> against the proposal number for verification and acceptance of demand notice by the Nodal Officer, FCA for accepting the demand online in the forest clearance portal. After accepting the demand notice by the Nodal Officer, the User Agency shall generate e-challan and deposit the funds into the Telangana State Compensatory Afforestation Fund Management and Planning Authority(CAMPA) account of Telangana against the Challan number. The step-by-step process involved is available at Ministry's portal

The Cost towards Boundary pillars, Extraction of tree growth, survey charges and the Bird reflector shall be deposited into the PD account of DFO, Siddipet for an amount of Rs.9,63,000/-


Further, the User Agency has to comply with following in accordance with the MoEF&CC, GoI instructions issued vide F.no.7-23-2012-FC, Dt.24.07.2013 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4, Dt.23.08.2013:

1. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one in vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.


Further, the User Agency has to furnish the compliance on the conditions stipulated in the Stage I (in-principle) approval for onward submission to Government for obtaining Stage-II (final) approval.

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval or working permission.

In view of the above the Executive engineer, Construction Circle, TSTRANSCO, Sangareddy is requested to kindly make the payment and submit the compliance report on the Stage-I approval for obtaining the final (Stage-II) approval.
