#### **ORDER:**

In the letter 1<sup>st</sup> read above, the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, has submitted a proposal under Section-2 of Forest (Conservation) Act, 1980, for diversion of 0.405 Ha of forest land in Compt.No.339 of Penukonda RF in Ananthapur Division for water supply improvements scheme with Gollapalli reservoir as source under AMRUT 2016-20, Ananthapuramu District, in favour of Superintending Engineer, Public Health Circle, Ananthapuramu and requested to accord approval in view of the guidelines issued from time to time by Government of India, Ministry of Environment, Forests & Climate Change, vide letters 2<sup>nd</sup> read above.

- 2. In the G.O.3<sup>rd</sup> read above, orders were issued, according approval in-principle (Stage-I) for the project, subject to fulfillment of certain conditions stipulated therein.
- 3. In the letter 4<sup>th</sup> read above, the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, has submitted the compliance report on the conditions stipulated in **in-principle (Stage-I)** approval accorded by the Government in the G.O.3<sup>rd</sup> read above and requested the Government to accord Stage-II (final) approval for the project.
- 4. After careful examination of the proposal and in exercise of the powers delegated to State Government in the guidelines issued by Government of India, Ministry of Environment, Forests & Climate Change, in the letters 2<sup>nd</sup> and 5<sup>th</sup> read above, State Government hereby accord **Final (Stage-II)** approval for diversion of 0.405 Ha of forest land in Compt. No.339 of Penukonda RF in Ananthapur Division for water supply improvements scheme with Gollapalli reservoir as source under AMRUT 2016-20, Ananthapuramu District, in favour of the Superintending Engineer, Public Health Circle, Ananthapuramu, subject to the following conditions:
  - i. The legal status of the forest land shall remain unchanged;
  - ii. Additional amount of the Net Present Value (NPV) of the diverted forest land, if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be paid by the User Agency.
- iii. Other conditions specified in the handbook of guidelines issued by the Government of India, Ministry of Environment, Forests & Climate Change, letter Dated 28.03.2019, shall also be complied with by Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh and the User Agency with which they are concerned;
- iv. The total forest area utilized for the project shall not exceed 0.405 Ha. In case the land is not taken over by the user agency or the same is not used for the stipulated purpose within a period of two years, then the area in question shall be taken back by the Forest Department;

- v. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of Comprehensive Guidelines of Forest (Conservation) Act, 1980 as issued by Ministry's letter No.5-2/2017-FC, dated 28.03.2019.
- 5. The Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh shall take further necessary action in the matter accordingly.
