MEMORANDUM:-

This department has given an "in principle" approval for Diversion of **0.4508 ha.** Protected Forest land for laying 125/90/63/32 mm MDPE gas pipeline along/across SH-2 (Jhalod-Suksar SH)(Ahmedabad-Santrampur) in Jhalod town and surrounding area to supply natural gas in Taluka Jhalod of District Dahod in favour of Dy. Manager (PR-RoU), Gujarat Gas Ltd., Ahmedabad, vide letter referred at Sr. No.(1) above.

The Nodal Officer (FCA), Gujarat has reported that the User Agency has deposited an amount of Rs.1,97,450/- through NEFT/RTGS, dt.22.12.2021 towards the cost of NPV in Adhoc CAMPA, New Delhi by NEFT/RTGS(Challan) & Processing Fees and Registration fee Rs.7520/- is deposited in 8782 Forest Remittance referred at Sr. No. (2) above.

The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act, 1980, subject to the following conditions:-

- This permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- The forest land shall not be used for any purpose other than that specified in the FCA proposal.

- 3. User Agency will have to obtain permission from the Nodal Officer (FCA), for carrying out any maintenance works in future.
- 4. User Agency will have to restore the forest land after use/ maintenance work. No tree shall be cut.
- User Agency will be liable to compensate any loss to Forests / Environment caused due to the use of the said land by the user agency.
- 6. User agency will seek permission from the Roads & Buildings Department/Science and Technology Department, Sachivalaya, Gandhinagar, if required so.
- 7. Gas pipeline will be laid underground in the trench of maximum depth of 2.00 meters and width of 0.4 meters, in between rows of road side plantation.
- 8. Additional conditions under chapter-5 of Forest (Conservation) Act, 1980 shall be applicable to this proposal as the Government of Gujarat's Resolution No.FCA-1013/11-10/11/SF-24/F, Dated 12.06.2015. The user agency shall be bound to comply additional condition as per the aforementioned resolution. The project authority has submitted undertakings for the same.
- 9. Any other condition, which the Nodal officer (FCA) may stipulate from time to time. By order and in the name of the Governor of Gujarat,
