MEMORANDUM:-


Deputy Conservator of Forests, Social Forest Division, Bharuch has accorded "in principle" approval for Diversion of **4.3892 ha.** of Protected Forest land for grant of permission admeasuring in Ta.Ankleshwar, Jambusar, Amod, Valia, Bharuch and Jhagadia of District Bharuch, Gujarat State in favour of Gujarat Gas Ltd., Gandhinagar, vide letter dated 09.06.2016 referred at Sr. No.(1) above.

The Nodal Officer (FCA), Gujarat has reported that the User Agency has deposited an amount of Rs. 19,22,470/- through Trans. Ref. No. 4440U17052410453, dt.21.02.2017 towards the cost of NPV in Adhoc CAMPA, New Delhi by NEFT/RTGS(Challan) & Processing Fees and Registration fee is deposited in Nodal Officer, FCA, Gujarat State, Gandhinagar, S.B.I. A/c No: 66013423126 Rs.7400/- referred at Sr. No. (2) above.

The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act, 1980, subject to the following conditions:-

1. This permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
3. The User Agencies shall generate challan through OSMFWC portal before making payment for Stage-II Clearance process. All the fund shall be deposited through OSMFWC portal by the User Agency.
4. The User Agency will have to obtain permission from the Nodal Officer (FCA), for carrying out any maintenance works in future.

5. The User Agency will have to make good the forest land after use/ maintenance work. No tree shall be cut.
6. The User Agency will be liable to make good any loss to Forests / Environment caused due to the use of the said land by the user agency.
7. The user agency will seek permission from the Roads & Buildings Department/Science and Technology Department, Sachivalaya, Gandhinagar.
8. The Gas pipe line will be laid underground in maximum trench of depth of 2.00 meters and width of 1.00 meters, in between rows of road side plantation.
9. The Net Present Value (NPV) for the area to be diverted under the proposal shall be deposited by the user agency as per the orders of the Hon'ble Supreme Court of India dated 30.10.2002, 01.08.2003, 28.03.2008 and 09.05.2008 in 1A-566 in W.P.(Civil) No. 202/1995 and as per the guidelines issued by the MoEFCC vide letters No.5-1/1998-FC(pt-II) dated 18.09.2003 as well as letter No.5-2/2006-FC dated 03.10.2006 and 5-3/2007-FC dated 05.02.2009 in this regards.
10. The additional conditions under chapter-5 of Forest (Conservation) Act, 1980 shall be applicable to this proposal as the Government of Gujarat's Resolution No.FCA-1013/11-10/11/SF-24/F, Dated 12.06.2015. The user agency shall be bound to comply additional condition as per the aforementioned resolution. The project authority has submitted undertakings for the same.
11. Any other condition, which the Nodal officer (FCA) may stipulate from time to time.
