TO WHOMSOEVER IT MAY CONCERN

In compliance of the Ministry of Environment and Forest (MoEF), Government of India's letter No.11-9/98-FC (pt.) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidence for having initiated and completed the process of settlement of rights under the scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA - for short) on the forestland proposed to be diverted for, non - forest purpose. Read with MoEF letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects. It is certified that ~~53.43~~^{54.97} hectares of forest land proposed to be diverted in favour of Madhya Pradesh Water Resources Department for Construction of **Hiran medium Tank Project** for irrigation purpose in Jabalpur District falls within jurisdiction of **Badhua, Badkur, Ghughra, Ghodatakan, Kuswadabra, Karanpura, Samnapur, Hadipani village** in Compartment No. 280, 282, 283 in Kundam Tehsil.

It is further certified that :

- The complete process for identification and settlement of rights under the FRA has been carried out for entire ~~53.43~~^{54.97} hectares forest area proposed for diversion. A copy of records of all consultation and meetings of the Forest Rights Committee (s), Gram Sabha (s), Sub - Division Level committee (s) and the District Level Committee are enclosed as annexure I to annexure II.
- The proposal for such diversion (with full details of the project and its implications, in vernacular / local language) have been placed before each concerned Gram Sabha dwellers, who eligible under FRA:
- The each of concerned Gram Sabha (s), has certified that all formalities / process under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion, A copy of certificate issued by the **Gram Sabha of Badhua, Badkur, Ghughra, Ghodatakan, Kuswadabra, Karanpura, Samnapur, Hadipani village (s) is enclosed as annexure (s).**
- The discussion and decisions on such proposals has taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present;
- The diversion of forest land of facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gram Sabhas have given their consent to it.
- The rights of primitive Tribal Groups and Pre- Agricultural Communities, where applicable have been specifically safeguarded as per section 3 (1) (e) of the FFA.
