## Status Report on AHMS, Mangalagiri.

I. Sanction of AHMS Mangalagiri:

Government of India sanctioned AHMS Mangalaguri to balance regional inequalities in health care in India. Cabinet approved setting up of AIIMS at Manglagiri in Andhra Pradesh. An M.O.U between MOH&FW, G.O.I and Govt. of Andhra Pradesh was signed. Government of Andhra Pradesh has already issued "Possession of land to the Central Govt. for construction of AIIMS.

II. Appointment of executive Agency.

The G.O.I has appointed HSCC (INDIA) as the Executive agency for construction of AIIMS, Mangalagiri.

III. Foundation stone ceremony.

Foundation stone was laid down by Honorable Minister for Health and Family welfare Sri.Jagat Prakash Nadda on 19thDecember2015 in the august presence of Honorable Minister of urban development Sri M.Venkiah Naidu. Chief Minister of A.P. Shri Nara Chandra Babu Naidu and Minister of Health Govt of A.P. Sri Kamineni Srinivas and other dignitaries.

IV.Appointment of Construction Agency for boundary wall

M/S KMV Projects Ltd was awarded with the tender for construction of boundary wall to AHMS Mangalagiri.

## V. Progress of work

The Boundary wall construction started and it spreads in a length of 4560 meters around AIIMS site. Till date 3725 meters completed. 290 meters work is on progress and another 545 meters with railway boarder is ear marked. The railways have been contacted and they agreed to relocate the signal lines that are on the way.

The Govt., General Hospital (Sanatorium) is completely vacated, equipment shifted and staff shifted to other hospitals. Now these vacant buildings are ready for

demolition.

The NDRF Battalion presently in the campus of AlIMS site was allotted land in Kondapavuluru village in Gannavaram Mandal. The Union Home minister Rainath Singh laid the foundation stone of the new NDRF campus on January 9, 2017.

Shifting of Power lines passing through AHMS: APSPDCL has estimate the cost to be of Rs.1, 92, 80,910/. Hon'ble CM in his review meeting on AlIMS held on 28-02-2017 has informed that the State Government will make arrangement for the payment of the amount from SDF founds.

Electrical Sub Station: Hon'ble CM has instructed the officials of forest to allot land between AIIMS and Railway tract for the establishment of electrical substation.

Approach Road to the National Highway on East side through 6th APSP Battalion is proposed. Sanction & construction is to be undertaken by R&B. In the review meeting held by Hon'ble CM on 28-02-2017, it was decided to lay the road by taking the land from both APSP and Forest department and R&B officials will be following up. However it was noted that there is some construction work going on at the northeastern corner of AIIMS compound wall which will be in the way of proposed road connecting national highway to AIIMS.
