01. Kind attention is invited to the subject and letters cited under reference.
02. The Ministry of Environment & Forests, Government of India, vide reference cited has granted prior approval for Diversion of 0.90 Ha. of forest Land for Installing of Submersible pumps, approach road, transmission line and water pipe lines of padmavathi Khani for a period of 10 years.
03. About 11.0 Million Tonnes of Coal deposits existing in Top Seam and King Seam of Padmavathi Khani can be extracted after de-watering No.1 Seam of 5 B Incline, which is a Coal conservation measure and for optimum exploitation of non renewable fuel source. Therefore constant bailing out of water from No.1 Seam of No.5B Incline is essential with already installed Submersible Pumps.
04. There will not be any additional mining /surface activity .the present activity like running & maintaining 2 pumps at Two spots and to let out the water or to use for various purposes will continue till the extraction of 11 million tones of coal from top & King seam i.e., in the next 20 years.
05. ETS& DGPS data for verification and authentication has been submitted vie ref 2nd cited .The same has been verified and communicated vide Ref 3rd cited. The charges amounting to Rs.3000/- has been paid vide SBI , Rudrampur Branch D/D dtd 07.01.2017 towards verification and authentication for ETS / DGPS data. The

Act 1980 along with relevant particulars/documents and Plans in 7 (seven) sets are submitted herewith for 1st renewal the Diversion of 0.90 Ha. of forest Land for continuing the water pumping activity in padmavathi Khani for a period of 20 years to extract about 11.0 Million Tonnes of Coal deposits existing in Top Seam and King Seams at PVK -5 Incline of Kothagudem Area, SCCL.
07. It is, therefore, requested to kindly arrange to process and forward the Application to Government of India through Govt. of Telangana for grant of prior approval for 1st renewal of diversion of 0.90Ha. Mining Lease for a further period of 20 years.
