In this connection , the foot tracks as detailed below are proposed to be constructed in the **District of Kurung Kumey**, Arunachal Pradesh for ITBP. This road (Foot Tracks) are strategically very important for the safety of nation and is being used by the ITBP and Military Personnels to reach and carriage of goods & ammunition etc. to protect Indian territory up to international Line of Control.
