No.DC(IE)/9/784/2018: In compliance of Ministry of Environment & Forest (MoEF), Govt. of India's letter No. 11-9/98 dated 05.03.2013, wherein the MoEF issued Guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA for short) on the forest land proposed to be diverted in favour of the Executive Engineer, Imphal East, PHE Division, PHED, Manipur for the Project namely "Construction of Water Supply Scheme at Heingang Awang Leikai, Imphal East".

It is further certified that:

- a The complete process for identification and settlement of rights under the FRA has been carried out for the entire 0.1395 Hectares of forest area proposed for diversion.
- b There is no forest dwelling Scheduled Tribes and Other Traditional Forest Dwellers in the entire 0.1395 Hectares of forest land at Heingang Awang Leikai Marjing Hill, Imphal East proposed for diversion by the Executive Engineer, Imphal East, PHE Division, PHED, Manipur
- c The proposed diversion does not affect the recognized right of Forest Dwelling Scheduled Tribes, Other Traditional Forest dwellers, primitive tribal groups and pre-agricultural communities as the proposed area is not inhabited;
- d The forest land proposed for diversion by the Executive Engineer, Imphal East, PHE Division, PHED, Manipur is located at Heingang Awang Leikai Marjing Hill, Porompat, Sub-division, Imphal East and lies within the jurisdiction of Heingang G.P, Heingang C. D Block.
- e The Gram Sabha of Heingang G.P, Heingang C. D Block has given its formal consent to the proposal for diversion of forest land for Construction of Water Supply Scheme at Heingang Awang Leikai, Imphal East at Heingang Awang Leikai Marjing Hill, Imphal East by taking a resolution to that effect in its meeting held on 24th April, 2018.

A copy of the resolution of the G.P in its meeting dated, 24th April, 2018 is enclosed for reference. This certificate has been issued with appropriate modification to the format prescribed by the Ministry of Environment & Forest (MoEF), Govt. of India's vide its letter No.F.No.11-9/98-FC(Pt.) dated 05.03.2013 in view of the non-existence of habitation and interests in the area proposed to be diverted.
