# Justification for Proposal.

In Maval tehsil there are two villages namely called as Ander Maval & Pavana Maval. On Pavana river the dam has constructed at Pavana Nagar. Due to Western Ghats hill range & back water of Pavana dam The Villages Apti & Gevende villages are become un-accessible & remote villages in Tal. Maval. For the basic needs of medical, Education Market, facility & also visit to Tehsil place villages must travel longer distance. & also, absence of public transport facility available. The villages using the path / kacha road for travelling to Kusgaon which is not suitable for jeepable. Gram Panchayat Kusgaon Bk. & Gram Panchayat Gevhande Apti has submitted Gram Sabha resolution to Zilla Parishad Pune. As the increasing population, there is need to provide alternative shortest distance road for better transportation facility. Considering all above facts, the district plan about 40 lakhs grant has been sanction by DPDC Pune to Forest Dept. Pune. But construction of road has not done.

After survey it is observed that, for construction of road joining ODR 69 To Kusgaon Bk. Tal. Maval, Dist.- Pune. Reserved Forest land required 0. 4902 ha. from g. no 380 & Private Forest land 0.2658 ha. from g no 315,316, & total 0.756 ha. at village- Kusgaon Bk. & Reserved Forest land 0.066 ha. from G no 26, & Private Forest land 0.123 ha. from gut no 128,127, & total 0.189, at Village- Gevhande (Apti), Tal. - Maval Dist. — Pune. Grand total forest land required is 0.945 ha. Forest land required for construction of road joining ODR 69 to Kusgaon Bk. Tal. Maval, Dist. Pune

P.A. has not started work on forest land & also on non-forest land. As this road is important to provide public utility & facility to local farmers & villages. There is no alternative other than proposed road alignment.
