TO ALL TO WHOM these present shall come, I, **Arun Kumar Girdhar**, General Manager (Regional Services), Indian Oil Corporation Ltd., Marketing Division, Northern Region, New Delhi-110016 send greetings :-

NOW FROM YE AND THESE PRESENTS WITNESS that in pursuance of the power of sub-delegation and substitution given to me by virtue of the hereinbefore recited General Power of Attorney dated 05/12/2008, I, **Arun Kumar Girdhar**, General Manager (RS) and duly appointed, Constituted Attorney of the Corporation, do hereby nominate, appoint and constitute the said **Shri Hemant Kumar, Asstt. Manager (RS), Moradabad-II Sales Area, Moradabad (U.P.), Indian Oil Corporation Ltd., (M.D.)**, as the attorney of the said Corporation with full powers and authorities in my name and/or in the name of and for and on behalf of the Corporation to exercise the following powers and authorities and to do the following acts, deeds, matters and things or any of them i.e. :-

1. To sign and execute lease agreements/licence deeds/sub-lease agreements for land for retail outlets and SKO sites and sale/distribution of other petroleum products with Govt, Semi-Govt. and private parties on behalf of the Corporation.
2. To present the documents for registration, if required by law, before the competent Registrar or Sub-registrar at the appropriate place or places to get the same duly registered.
3. To sign, verify, declare and execute written statements, counter-claims, petitions, appeals, review applications, affidavits and papers of every description that may be necessary to be signed, verified and executed for the purpose of any suit, appeal, review, legal application, criminal and civil proceedings of any kind whatsoever in any court of law or justice whether original, appellate or revisional jurisdiction.
4. To apply for and appear before various authorities with regard to change of land use and file and execute all connected documents/deeds/papers in regard to the same.
5. AND generally to make to do all acts, deeds, matters and the things on behalf of the Corpn. as may be necessary and incidental to the powers hereinabove mentioned.

AND IT IS FURTHER hereby declared that the fact of the said, **Arun Kumar Girdhar** at any time and times hereafter himself performing or doing all or any of the acts, matters, deeds or things hereinbefore mentioned shall not be deemed to revoke, cancel or otherwise prejudice any of the powers or authorities conferred by these presents.



AND I, the said General Manager(RS):NR, do hereby agree to allow, ratify and confirm all and whatsoever the said **Shri Hemant Kumar, Asstt. Manager (RS), Moradabad-II Sales Area, Moradabad (U.P.), Indian Oil Corporation Ltd., (M.D.)**, shall or may lawfully do or cause to be done in or about the premises virtue of these presents.




