In the reference 1<sup>st</sup> cited, the State Government has accorded in-principle (Stage-I) approval for diversion of forest land U/s- 2 of Forest Conservation Act, 1980 over an extent 0.933 Ha of forest land in Atmakur Range of Neliore Division for up-gradation of existing road from Km.641/000 to 643/083 and from Km.657/000 to Km.657/478 of NH-67 two lane with paved shoulders in the State of Andhra Pradesh under NHDP – IV in f/o Executive Engineer, (R&B), NH Division, Kadapa subject to certain stipulated conditions.

In the reference 2<sup>nd</sup> cited, the Prl. Chief Conservator of Forests (HoFF), A.P. Guntur has communicated the State Government approval in-principle (Stage-I) and instructed to raise Demand Notice to the User Agency for payment of Net Present Value (NPV) amount. The Prl. Chief Conservator of Forests further instructed to obtain compliance as per the conditions stipulated in the reference 1<sup>st</sup> cited from the user agency.

For fulfillment of condition No (iii) the user agency has been requested vide DFO, Nellore Rc.No.673/2015/F11, dt.27-03-2017 to deposit an amount of Rs.4,08.654/towards NPV. The same is yet to be deposit by the user agency. As per telephonic instructions of the Prl.Chief Conservator of Forests, AP, Guntur, dt.13-04-2017, the CA scheme is prepared to the 10 times of trees likely to be felled with a financial outlay of Rs.10.078 lakhs and submitting to the Chief Conservator of Forests, Guntur requesting to accord permission so as to issue demand notice to the user agency. In the reference 6<sup>th</sup> & 7<sup>th</sup> cited the Prl.Chief Conservator of Forests, AP, Guntur and the Chief Conservator of Forests, Guntur have instructed the undersigned to issue demand notice to the user agency for payment of two times the number of trees felled on the diverted forest land (i.e 45x2 = 90)

trees) to maintain the green cover at the project cost as per the GOI Ir., dated.13-02-2014. Hence, the user agency has to deposit the following amount.
