## Justification for locating the project in Government Land

Police Post Jutog is under the jurisdiction of Police Station West Shimla has been created in Britsh era and functioning in Cantonment Board area Jutog. The Police Headquarter Himachal Pradesh letter Endst. No. Estate-1-4/83-IV-SML-9592 dated 9.4.2013 has also proposed to ensure compliance on the implementation of the construction work on priority basis. The Police Post Jutog is situated at a distance of 8 KM from District Headquarters. The population as per the census of 2011 of PP Jutog is about 60,000. This office had made the correspondence with Panchyati Raj Deptt reg. available of land in Kh. No. 95-96 Patwar Circle Tutu but they have refused to provide above land due to department necessity. Secondly this office had made the correspondence with the old building of Himachal Pradesh State Electricity Board at Tutu but this building has already been transferred in the name of Health Department with the approval of H.P Govt. There is no other non forest land is available in Mohal Totu and Jutog Cantt. On 20.1.2017 the Joint Inspection Committee ( Concerned SDM, Forest Deptt., HPPWD Deptt. and M.C Shimla) has selected the Khasra No. 1/2/1 Mohal Totu for the construction of Police Post Jutog as the said land is suitable for the construction of above Police Post as there is no water resource place, common path, cremation ground etc. and above khasra No. is suitable for general public and also be centrally able to look after the law and order from this particular site. This site has also been selected as there are lesser trees are standing as compared to alternative site. Hence Joint Inspection Committee has selected above land and also recommended khasra No. 1/2/1 for the construction of Police Post Jutog.


