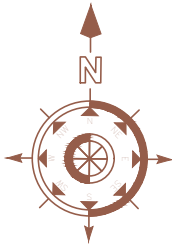
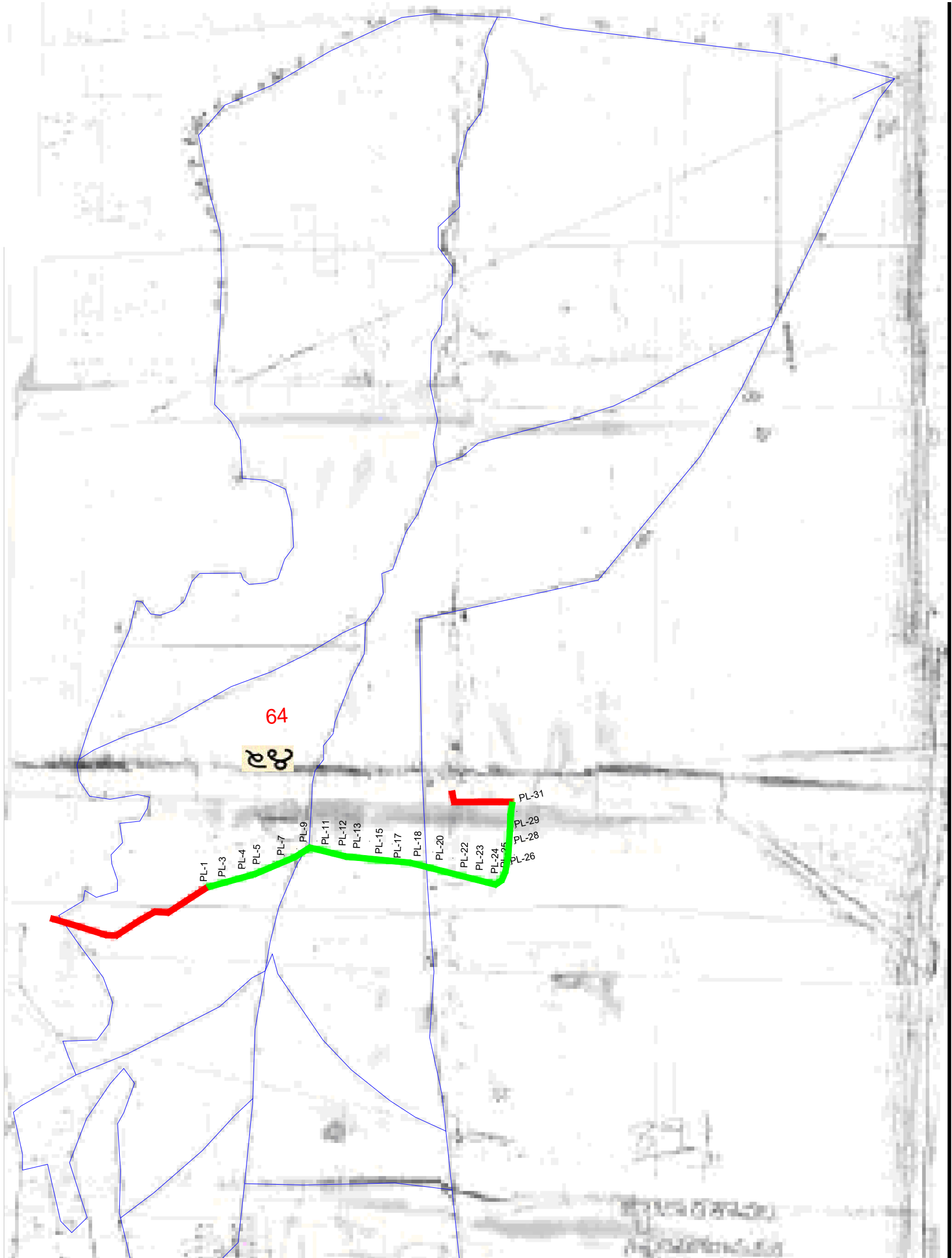

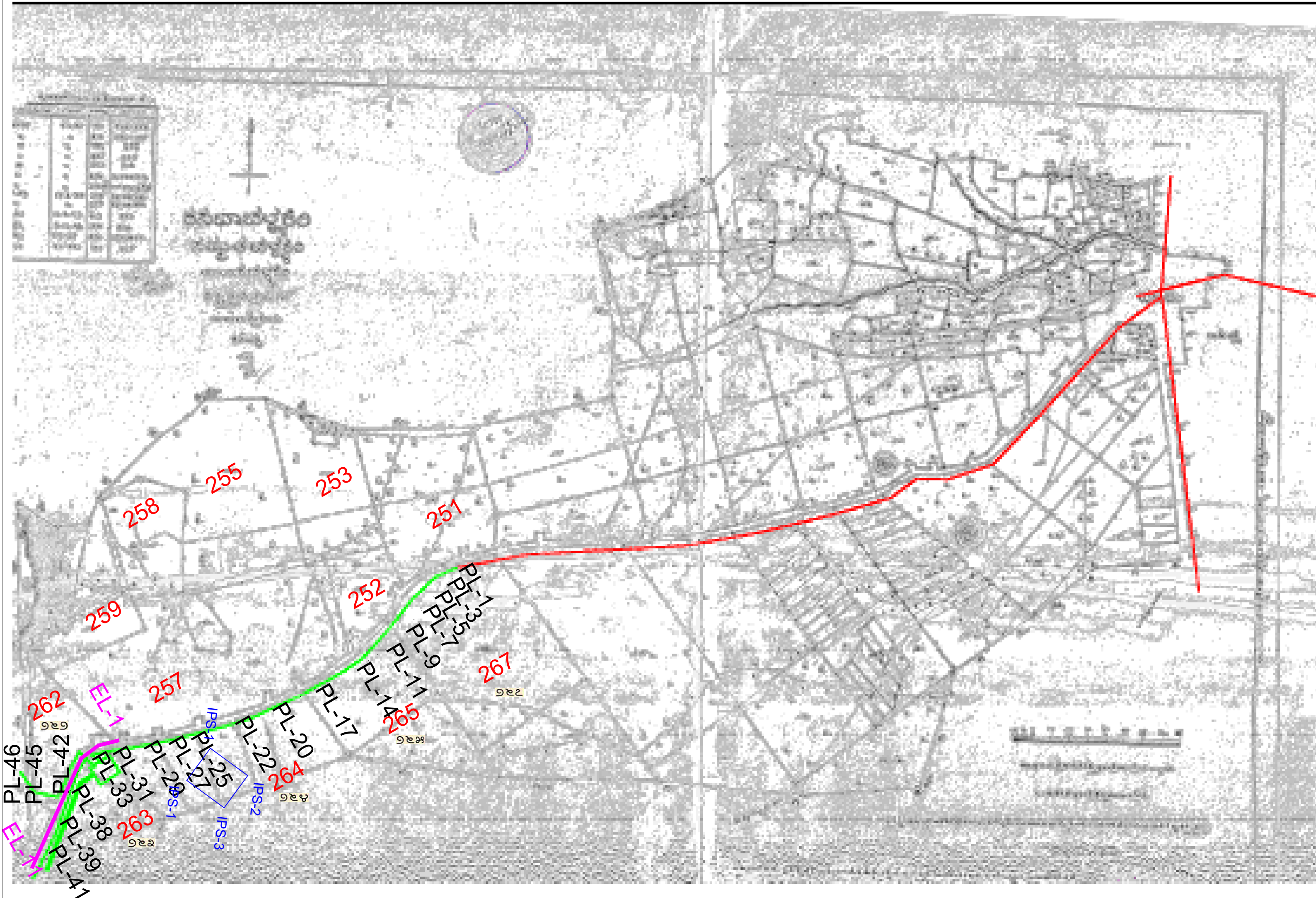

Village Map Challakere Town (Hobli), Challakere Taluk, Chitradurga District

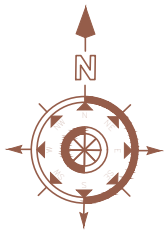

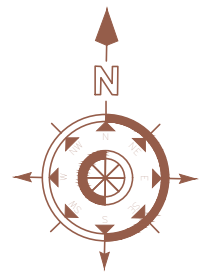

VILLAGE MAP OF KELAGINNAKANIVE VILLAGE WITH SURVEY NO AND FOREST AREA DETAILS



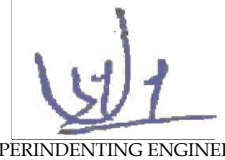
