### Justification and Detailed note of the Project

The Department of Road Transport and Highways , Government of India, represented by the Secretary, Ministry of Road Transport & Highways on behalf of the President of India acting through the Project Director (NHAI), National Highways Authority of India, PIU, Khammam (the "Employer") is engaged in the development of National Highways and, as part of this endeavor, the Employer has decided to undertake work of "proposed diversion of 1.8571 ha of forest land for construction of 4 lane access controlled New Green field Highway Section of NH 365 BG Khammam Devarapalli of length 309.52 Mts. from **Thallampadu Village to Somavaram Village** in Velugumetla RF of Khammam forest Division District in favour of Project Director, PIU, NHAI, Khammam.

#### Project objectives:

- Reduces the distance between Rajahmundry and Hyderabad by 56 kms and between Khammam to Devarapalle by 24 kms.
- Substantial gains in terms of Vehicle operating Cost, reduced travel time and will boost the economic development of the adjoining areas.
- The aim of the project is to improve connectivity between Telangana State & Andhra Pradesh State and is being closely monitored under PRAGATI.
- Decongest/reduces the load of NH-16.

The Government of India, MoRTH (by NHAI) under Inter Corridor Route (ICR) under BHARATMALA PARIYOJANA programme has taken up Construction of four lane Access Controlled New Greenfield Highway Section of NH-365 BG (Khammam -
