SPECIAL POWER OF ATTORNEY

KNOW ALL MEN BY THIS POWER OF ATTORNEY:

AND WHEREAS the Company has appointed Mr. Amitabh Sharma as Assistant Vice President - Network Services in the States of Punjab (including Chandigarh), Himachal Pradesh and Jammu & Kashmir service area.

AND WHEREAS for the discharge of his duties and responsibilities, it is necessary to delegate to him (Mr. Amitabh Sharma) the power to represent the Company for the following purposes in the States of Punjab (including Chandigarh), Himachal Pradesh and Jammu & Kashmir service area.

NOW KNOWN MEN ALL BY THESE PRESENTS WITNESSETH that I, the said Himanshu Kapania, Managing Director of the Company, do hereby nominate, constitute and appoint Mr. Amitabh Sharma, Assistant Vice President - Network Services in the States of Punjab (including Chandigarh), Himachal Pradesh and Jammu & Kashmir service area to act on behalf of the Company and to do all such acts, deeds and things hereinafter mentioned in the name of and on behalf of the Company and his specimen Signature appears at the end of this document to be the true and lawful attorney in fact and at law of the Company for and in the name and on behalf of the Company to do, execute and perform all or any of the following acts, deeds, matters and things in relation to Interconnection matters with Bharat Sanchar Nigam Limited pertaining to the States of Punjab (including Chandigarh), Himachal Pradesh and Jammu & Kashmir service area in respect of the Company's GSM /UAS/NLD Licenses:

- To make necessary application to Bharat Sanchar Nigam Limited ("BSNL") for obtaining Points of Interconnects, POI Ports (E1s), POP Collocation, Leased Lines for connectivity (SDH Equipment) in the States of Punjab (including Chandigarh), Himachal Pradesh and Jammu & Kashmir service area.
- To settle and make payment of the IUC Bills, submit the IUC Bills together with the other required documents to BSNL and enter into settlement with BSNL in case of disputes in IUC Billing or related concerns.
- 3. To discuss, sign and execute Agreement(s) documents, deeds and things (including any amendments, changes, modifications, addendums, supplements thereto) as may be necessary for giving effect to the above mentioned purpose(s) and submit all details / information on behalf of the Company to Bharat Sanchar Nigam Limited ("BSNL").
- 4. And to deal with all such things, deeds or acts as may be necessary, incidental or *expedient for the accomplishment of the above objectives and the Company hereby undertakes to ratify and confirm whatsoever acts, deeds and things the abovesaid Attorney shall do or cause to be done for the Company by virtue of the Special Power of Attorney hereby granted to him.
