Project details: Construction of 2-lane Tarku-Damthang-Namchi road in South Sikkim under SARDP-NE Phase-A.

(i) Short narrative of the proposal and project / scheme for which the forest land is required.

The Government of India has granted a sanction of fund for the work, Construction of 2-lane Tarku-Damtnang-Namchi road in South Sikkim under SARDP-NE Phase-A, for the development of State Highway having a length of 32.00km distance. This road was constructed prior to the merge of Sikkim in India having a ROW of 16.45m and carriage width of 3.75m as a single lane road. But this existing road was found to be very congestion of vehicular traffic due to tremendous increased of traffic volume, hence, the said project has come up with double laning road.

This project incorporates with heavy widening work and sub-grade works which are required to be done to achieve formation width of 10.00m for double lane road. The earthwork/muck generated from widening work and sub-grade work has to be disposed off in the allotted dumping yards of Forest land or private land along the project road. Due to limited allotted dumping yards in the Forest land and private land, this has necessitated the additional dumping yard along the project road. The joint inspection has been carried out for dumping sites at Jaubari and Tifindara along Damthang-Namchi road.

Therefore, the diversion of 0.9755Ha of Forest land for dumping yards at Jaubari (300x250ft) and Tifindara (200x150ft) along the project road for the above project has been proposed.

- (iii) Cost of Project: The total sanction cost is Rs.203.26 Crore.
- (iv) Justification for locating the project in forest area. Out of 32.00km length of road, the 12.00km road length falls in Forest area along Damthang-Nmchi road. The suitable location for dumping sites is not available in the private land along this road stretch, however, the diversion of 0.9755Ha of Forest land for dumping yard at Jaubari (300x250ft) and Tifindara (200x150ft) along the project road for the above project has been proposed in view of the availability of Forest land and its suitability.
