The name of the project is "Rural connectivity road (RCR) from Bakchung to Thangshing". This will be a very important road and will be the life line of people residing this area. This road is 1.43 Kilometer long and connects internal villages i. e. Bakchung, Thangshing, Tokal & Bermiok. The entire village depends upon agricultural production to run their livelihood. There is no road connectivity for these villages and hence the Government has decided to upgrade the locality by providing/constructing a rural connectivity road funded by PMGSY has been sanctioned by the concern Ministrey.
