In case any of the Attorney's ceases to be in the employment of the Company, then the rights to such attorney under this instrument will extinguish forthwith

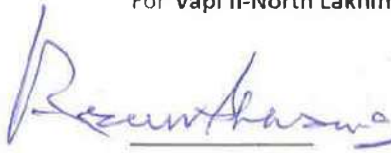
